

**Thirsk Town Council and Burial Board  
Fees for Thirsk Cemetery**

**With effect from 1<sup>st</sup> April 2024**

**Inhabitant or Parishioner of the Parish of Thirsk**

The fees set out below apply as follows:

- a) where the person to be interred, or in respect of the person to whom Right of Burial is granted is, or immediately before death was, an inhabitant or parishioner of the Parish of Thirsk, or
- b) in the case of a still-born child, where the parents are, or at the time of interment were, such inhabitants or parishioners

In all other cases **the Fees will be doubled**, except where the Exclusive Right of Burial in the grave in question, or the Right of Constructing the grave, was acquired at the single fee as set.

**A Exclusive Rights of Burial**

Fees charged for Exclusive Rights of Burial are **additional** to Interment Fees which are shown separately.

The Fees in Part A include the **Deed of Grant**

**Part A 1 Earthen Graves**

Exclusive Rights of Burial in an earthen grave for a period not exceeding 99 years:

In an earthen grave 9 feet by 4 feet (single or double depth) **£265.00**

**Part A 2 Garden of Rest**

No Exclusive Rights of Burial granted in the Garden of Rest

Reservation of space in the Garden of Rest **£138.00**

## **B Interment Fees**

**Part B 1 For the burial in a grave**, whether or not an Exclusive Right of Burial has been granted:

| a) | of the body of a stillborn child, or of a child whose age at the time of death did not exceed one month | <b>No charge</b> |
| b) | of the body of a child whose age at the time of death exceeded one month but did not exceed 16 years    | <b>£79.00</b>    |
| c) | of the body of a person whose age at the time of death exceeded 16 years                                | <b>£268.00</b>   |

**Part B 2 For the burial of cremated remains:**

| b) | in a Garden of Rest (no Exclusive Right of Burial)                           | <b>£138.00</b> |

## **C Monuments, Gravestones and Monumental Inscriptions**

**Part C 1 For the Right to Erect or Place on a Grave** in which an Exclusive Right of Burial has been granted:

| a) | <b>A Headstone</b> – not exceeding 5 feet in height and 2 feet 6 inches in width | <b>£69.00</b> |
| b) | <b>A Vase</b> – not exceeding 18 inches in height                                | <b>£32.00</b> |
