C1697 Declarations of Interest

There were no declarations of interest.

C1698 Police Report

There was no police representative in attendance, but a police report had been received to which no comments were made.

C1699 Reports on Matters Relating to Thirsk North Yorkshire Council

Cllr Dadd informed the meeting of his concerns regarding the costs to dispose of commercial waste in the area, and it was hoped that it will be possible to limit the number of visits of a commercial vehicle to 12 times a year.

Cllr Dadd stated that he had been shown evidence of the challenges faced in respect of the roadworks on Station Road Thirsk.

Cllr Trueman enquired of Cllr Dadd regarding an update of the footpath repairs in the marketplace. Cllr Dadd stated that it was hoped the repairs would be completed by the beginning of December following a contract change.
