Minutes of a Meeting of Thirsk Town Council, held in the Court House on Monday, 14th April 1986 at 7.30 p.m.

A. J. Davison, E. R. Stott.

Minutes The Minutes of the Annual Assembly and the March Council Meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Allenby, sec. Coun. Craig.

Matters Arising from the Minutes

Seats The Chairman reported that R.A.O.3. Cliff Top Lodge are to meet with the N.Y.C.C. Highways Dept. representative to discuss a suitable site for their presentation seat.

Height Barrier - Car Park

Council employee. A copy letter to the Chief Executive H.D.C. from Thirsk Museum and Tourist Information Centre was read to the meeting, putting forward suggestions for improving car and coach parking in the town and car park.

Coun. Craig reported that the Leisure and Amenities Committee were considering making the small car park, in the vicinity of Gillings Court, available for coach parking and allowing the parking of coaches on the car park road. The Chairman stated that coach parking on the highway should be allowed to prove whether there is a need for coach parking and the road made 'one way'. It was agreed to write to the Chief Planner and Technical Officer requesting an 'update' on coach parking and also requesting a site meeting with District and County Council officers and the Chairman and Vice Chairman of the Leisure and Amenities Committee.

The Clerk had received a verbal quotation for a self starting motor for the clock of £1,268.00. Members agreed that this cost could not be met. The work on the clock face had been completed and the account presented for payment. Coun. Stott submitted a written report stating that there is too much play between the clock hands and the drive spindles. He had been unable to re-set the hands correctly and did not recommend passing the account for payment. It was pointed out that there is a Year's guarantee on the work. Wm. Potts & Sons to be asked to rectify the matter and the cheque for payment to be signed.

Conservation Area Enhancement Schemes Nothing reported.

Coun. Craig had shown members a hanging basket of artificial flowers at the meeting to discuss the Thirsk District Plan Position Statement. Prop. Coun. Criag, sec. Coun. Murkett 'that the Town Council meet the cost of three hanging baskets if the Chamber of Trade will meet the cost of the remaining three.' Agreed. Mr. Paul Turner, Chairman of the Civic Society, who had offered his services free of charge to plant and maintain the White Mare Roundabout this year if the Council provides the plants and materials, submitted his planting scheme. Members were pleased to accept Mr. Turner's offer and scheme and agreed to meet the cost of mulch, fertiliser and plants. Mr. Woods, N.Y.C.C. Divisional Surveyor, had informed the Clerk that £35.00 would be available towards the roundanout maintenance for the past financial year and £70.00 for the present one. That, with the balance of the amount set aside for floral

decorations, would make £240.00 avaialable for the roundabout scheme. The Council's insurance to be checked for cover for Mr. Turner when working on the roundabout.

Road - Little Green to The Crescent Nothing reported.

Transport for Hospital Visiting Nothing reported.

Tree - Stockton Road Reply from N.Y.C.C. still awaited. A letter from Coun. Roberts stated that many trees have been planted in the verge of Stockton Road without permission and have enhanced the area. When the N.Y.C.C. has made up its mind, the Town Council should take responsibility for the tree when it is planted.

Public Payphones

Coun. Craig reported on the meeting with a representative of Telecom and Mr. Johnson of H.D.C. Several sites had been viewed and considered. The Chairman told members that red telephone boxes are available if they are insisted upon and he has been told by H.D.C. that red boxes are to be provided for the Market Place. Members had received numerous complaints regarding the absence of public telephone facilities in the Market Place. Mr. Johnson to be asked when the situation will be resolved.

Notice Board - Sign Nothing reported.

Grass Cutting

A letter from Mr. J. A. Boot of St. Mary's Walk told members that the
cost of grass cutting could be reduced by the replacement of three grassed
areas in St. Mary's Walk with tarmac. These grassed areas are being continually fouled
by dogs. The Chairman told the meeting that these areas are the responsibility of the
N.Y.C.C. and felt that if the N.Y.C.C. could waste public money by exte/nding the path
at the south side of Station Road which serves no useful purpose, they could spend money
on replacing the grass verges of St. Mary's Walk. It was agreed to write to the County
Surveyor stating the Council's views on this footpath and also to Coun. Turton, asking
him to attend the June Council Meeting to discuss this and other matters appertaining to
the County Council.

Encroachment at Whitelass A copy letter from the Chief Planning Officer to the owners of 11, Whitelass Close stated that the Enforcement Officer had visited the garden and noted that quickthorn had been planted along the full length of the northern boundary. Reasonable steps had therefore been taken to comply with the planning condition. No information was to hand as to whether the wall had been removed.

Thirsk Local Plan Position Statement Minutes of the meeting, held to comment on the Position Statement were read.

Public Transport in North Yorkshire

A letter had been sent to the County Surveyor expressing the Council's concern at the lack of public transport for evening hospital visiting at Northallerton.

Keep Northallerton Tidy Campaign

It was reported that Coun. Davison had attended the A.G.M.

Planning Application - A. B. Rose

Two letters were presented from Mr. R. Sharphouse, acting on behalf of Mr. A. B. Rose, regarding the comments made on the application for the erection of a silo for the storage of joinery waste at The Furniture Factory, 1, Sutton Road. The letters stated that the silo is part of a new heating/waste disposal plant, to replace a previous installation, which at some stage gave rise to complaint from people living nearby. The equipment concerned is the most advanced obtainable at the present time as regards efficiency, in particular air pollution. Members were told that the silo has already been erected and endorsed the comments made at the March meeting. It was reported that the west boundary wall of Mr. Rose's premises is in a dangerous state. A letter to be sent requesting, in the interests of public safety, that repairs be carried out.

Street Sweeping Programme Review

Having considered the contents of the letter presented at the March meeting, it was decided to reply that the Council accepts the proposals in principle but request more information on how they are to be achieved.

Cometery Cutters

Coun. Loveden reported on the meeting at the Cemetery, held to discuss the grass cutters, and attended by himself, Coun. Craig, Coun. Bickers and the Clerk. Two cutters were available for inspection, the third was still at Harland (Garden Machinery) Ltd and not considered worth repairing. Coun. Loveden had made enquiries regarding the leasing of a grass cutter during the cutting season. A quotation of £10.00 + V.A.T. per week was received from Power Point Services.

Coun. Roberts submitted details of grass cutters - one of which, according to the suppliers and if properly maintained should last for 10 years, mowing every day in the cutting season.

Coun. Roberts also advocated the use of a growth retarding spray on the Cemetery grass, which would slow down the growth of the grass so that it would not requiring such frequent cutting. After due consideration it was Proposed Coun. Loveden, sec. Coun. Craig 'to accept the quotation from Power Point Services and lease a grass cutter for the 1986 cutting season.' Agreed. It was also agreed to retain the three grass cutters and store in the Council's shed until it has been ascertained whether leasing a cutter is satisfactory.

Coun. Foxton reported that she and Coun. Loveden have completed a Community Adviser's Course. She stated that it is essential that the Emergency Plan is completed so that Thirsk can respond positively in any emergency. Coun. Foxton and Coun. Loveden will complete the Plan and present it to the Council. It was agreed that the Emergency Plan will be reviewed annually at the Annual Assembly.

Correspondence

Public Conveniences - Market Place
by the Chairman and Coun. Davison at the Local Plan
Position Statment meeting regarding the unhygenic state of the public conveniences
which are now considered to be unnecessary since the provision of facilities on the Car
Park. Dr. Harrison stated that the Market Place conveniences are a health hazard.
It was agreed to forward the letter to the Chief Executive H.D.C. and request that the
previous decision not to demolish the building be reconsidered.

Town Clock Letter presented from Wm. Potts & Sons requesting an increase in the Annual Maintenance charge for the present financial year from £38.00 + V.A.T. to £43.00 + V.A.T. and pointing out that the account is submitted at the end of the twelve month period and not at the beginning as with many other contract services. It was agreed to accept the increased charge.

Association of Local Councils

Notice presented that as from 1st April, the Yorkshire & Cleveland Local Councils Association will be known as the Yorkshire Association of Local Councils, the Cleveland Branch having formed its own Association.

Yorkshire Day

Letter presented inviting the Mayor to attend the Second Yorkshire Civic

Procession to celebrate Yorkshire Day which is to be held this year at

Ripon, and requesting a contribution of £25.00. It was agreed that Thirsk will not be
represented.

Cemetery Superintendent

It was agreed to award an increase in salary of 5% in line with the cost of living index and as agreed in the Cemetery

Superintendent's contract. This to commence on 1st April and making an increase of £145.00 for the year.

A letter from Mr. M. Cresswell, and enclosing a copy of a letter sent to all the members of H.D.C. Planning Committee, was presented. The letter expressed Mr. Cresswell's fears for the future of his shop at 20, Finkle Street, the loss of his frontage, the demolition of listed buildings and the dangerous access/exit to the proped site. Mr. Paul Turner, Chairman of the Civic Society, told the meeting that the demolition of listed buildings as propsed would devastate the

Plans cont.

Members made the following observations: The Council is totally opposed to the proposed entrance/exit in Finkle Street, an already busy and very narrow street. The proposed entrance/exit is in the vicinity of a hump backed bridge which impedes visibility. The Council is also totally opposed to the demolition of any buildings in Finkle Street, both listed and unlisted. A supermarket on the proposed site is not considered to be in the interests of the town.

Any Other Business

Cutbacks in Public Transport Coun. Craig complained of the cutbacks in bus services, especially those between Thirsk and Northallerton.

Memorial Stone The Chairman told members that the memorial stone and plaque, erected in front of the tree planted by the late Mrs. Alice Metcalfe in her 100th year has been stolen. It was agreed to ask Mr. Collinson to provide another one.

The meeting closed at 10.40 p.m.

Minutes The Minutes of the previous meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Murkett, sec. Coun. Loveden.

Mr. Christopher Lewis, Headmaster of Thirsk School attended the meeting to tell the Council of his aims for the school.

He said that schools should reflect the best standards of the community and a good Comprehensive school should be rounding up standards. The atmosphere should be orderly and disciplined and the staff should care. Pupils should be taught to respect other peoples views and property. Schools should be open to the community and with frequent visits by parents. Mr. Lewis said that he is always available to pupils, staff and parents. Parents should be well informed about the school and bulletins are published for this purpose, copies of which will be supplied for the Council. Difficulties have been experienced due to industrial action by the teachers and staff are still not carrying out 'out of school' duties, but the situation is improving. Mr. Lewis stated that he wants staff support and understanding and welcomes constructive criticism and comment. To Coun. Foxton's request for his views on a Junior Civic Society, Mr. Lewis replied

Coun. Brannon suggested that members should visit the school and identify themselves to the pupils. Mr. Lewis felt that the 6th Form would like to receive the Council. On the question of pupils wandering around the town at lunchtimes, Mr. Lewis hoped that this situation would end when the teachers dispute is settled and lunchtime supervision in school available again. Regarding the litter problem, it was agreed that the adult public set a bad example. Mr. Lewis told members that if specific cases regarding litter or vandalism are reported to him, he will take action.

The Chairman thanked Mr. Lewis for his attendance.

Matters Arising from the Minutes

Seats A letter from the Secretary of R.A.O.B. Clifftop Lodge requested a meeting with members of the Council to discuss the siting of the seat that they had donated. A meeting was arranged for 7.00 p.m. on 22nd May on site. Coun. Murkett reported that the residents of No. 2, Alexander Close were pleased to agree to the siting of a seat on their land on Stockton Road from where the previous residents had demanded its removal.

Height Barrier & Coach Parking

A letter from the Chief Planner & Technical Officer stated that the Leisure & Amenities Committee has arranged for the barriers at Millgate Car Park to be open from 7.30 a.m. to 10.00 p.m. between April and October and from 7.30 a.m. to 4.00 p.m. between November and March. The Council has discussed the matter of parking in Thirsk but has not made any financial provision to cater for coaches, other than the use of Millgate Car Park. It was suggested to wait to see if any problems emerge from the use of Millgate for coach parking over the next two months before convening any joint meeting on the lines proposed by the Town Council. Members were not satisfied with this reply and it was agreed to request the meeting as a matter of urgency. Coun. Brannon stated that tour buses are parking on the area reserved for service buses on the Market Place and service buses are unable to find parking space. Coun. Murkett stated that buses should be allowed to park on the side of the road through the Car Park for a trial period and the situation monitored to prove the need for a Coach Park.

Cod Beck Drainage Rates

The meeting with representatives of the Water Authority and the Cod Beck Internal Drainage Board is to take place in the Town Hall on Thursday, 22nd May at 2.30 p.m. Coun. Murkett told members that he had invited Mr. Tyas, who had drawn up the petition, to attend. Members were in agreement.

Town Clock The Clerk reported that Wm. Potts & Sons had been to adjust the hands.

Conservation Area Enhancement Schemes Coun. Foxton reported on a meeting with Mr. Robinson of the Chief Planners Department who was in agreement with the proposal and thought that help would be available from the British Trust for Conservation Volunteers.

Floral Decorations It was reported that the Chamber of Trade had refused to co-operate by meeting the cost of three hanging baskets. Members were of the opinion that baskets of artificial flowers should be provided for the Council's lamp standards on the south side of the Market Place. Prop. Coun. Murkett, sec. Coun. Bickers 'that the resolution to provide three baskets if the Chamber of Trade will also provide three' passed at the April meeting be rescinded.' Agreed. Prop. Coun. Murkett, sec. Coun. Bickers 'that this Council meet the cost of six hanging baskets'. Voting - 8 in Favour - 2 Abstentions.

Road - Little Green Nothing reported.

Transport for Hospital Visiting Nothing reported.

Tree - Stockton Road

The Clerk had been informed that the N.Y.C.C. have now received replies from the statutory bodies and that Mrs. Elliott will be contacted regarding a suitable site for the tree.

Public Payphones

A letter from the Chief Executive H.D.C. stated that the Post Office have declined to give British Telecom approval to the siting of the telephone kiosks on the eastern gable wall of the Post Office. Accordingly, British Telecom intend siting the kiosks on the western side of the Public toilets and they will be of the new design.

Notice Board - Sign The Clerk reported that a 'Thirsk Town Council' sign has been obtained at a cost of £4.00% Members approved this action.

Footpath - Station Road Coun. Turton had telephoned the Clerk to say that he is unable to attend the June meeting but that he will make enquiries about the footpath.

Encroachment at Whitelass Coun. Roberts reported that part of the wall has been removed.

Planning Application A. B. Rose
Members were told that the planning application for the siting of a silo was being advertised even though the silo had already been erected. It was agreed that at its present height the silo is unacceptable and to request the planning department, on behalf of local residents, to insist that it is reduced in size to below roof level.

Street Sweeping Programme Review Nothing reported.

Cemetery Grass Cutter

The Cemetery Superintendent had informed the Clerk that the new cutter is not satisfactory. Coun. Loveden had contacted Power Point who will exchange it for a high dome cutter at the same cost. Members agreed with this action.

Public Conveniences - Market Place
A letter from the Chief Executive H.D.C. stated that the Environmental Health and Control Committee will be advised of this Council's views concerning the possible demolition of the conveniences. The Chairman, who is a member of that committee told members that he will press for demolition. A letter from Mrs. H. J. Fairwood of Sessay applauded the Council's efforts to have the conveniences demolished.

Tree Planting Coun. Foxton reported that oak and willow trees have been planted in The Holmes.

Footpath - Biggins Hill
The Clerk told members that this is being investigated by the Divisional Surveyor N.Y.C.C.

Heavy Lorries through Thirsk Reply awaited from the County Surveyor.

Memorial Stone Coun. Bickers stated that the stone had not been stolen and was at a house in Norby. The Clerk told members that a new stone had been ordered.

<u>Christmas Lights</u> It was requested that this be deferred until the next meeting. Correspondence

Seats - Ingramgate

A letter from Lester & Hatch, Solicitors, stated that in the will

of the late Mrs. Mabel Annie Shaw of 10, Ingramgate the following
legacy was bequeather. To the Town Council of Thirsk, sufficient funds to provide three
seats in Ingramgate, Thirsk inscribed 'Gift of family of W. A. Johnson'. Mr. Hatch had
told the Clerk that he envisaged teak seats. Coun. Foxton agreed to make enquiries of
Mr. Jeffray of Sessay and Coun. Murkett to contact Mr. Pipes of Carlton Husthwaite
regarding the making of 6' teak seats. It will be necessary to obtain permission for
the siting of seats in Ingramgate.

Town Hall - Insurance A letter from the Secretary of the Town Hall enclosed a copy of a letter from Municipal Mutual Insurance stating that the recommended cover for the Town Hall would be for £233,400.00 with a premium of £233.40. Cover of £200,000.00 is at present in force. It was agreed to request a representative of the insurance company to meet the Town Hall representatives of both Councils to discuss this matter.

Bryan Osborne Two letters presented from the Secretary, Yorkshire L.C.A., the first stating that Squadron Leader Bryan Osborne had died shortly after retiring as Assistant Secretary. The second letter stated that a retirement fund had been set up with a view to making a presentation but since his death it was felt that it would be right to set up some sort of memorial to Bryan Osborne. As this Council had previously considered making a contribution to a Presentation Fund, it was agreed to make a donation of £5.00% from the Chairman's Allowance, to the Memorial Fund.

Community Care Association Guide

Letter presented from Yorkshire Publishing who have
been asked by the Community Care Association to produce
a Community Guide of 4,000 copies, with updated information, following two previous
guides of only 500 copies produced by the C.C.A. It is the intention to provide one for
every household in Thirsk and Sowerby. Financing of the guide will be through the sale
of advertising groups to local companies. The amount of editorial will be dependent /cont

C. C. A. Guide cont. upon advertising sales. To make the project as successful as possible, a lot of support is needed from local traders and it would be extremely helpful to know that they have the backing of the Town Council before approaching potential advertisers. Members agreed to give moral support to the project and wish it every success but regretted that financial support was not available.

Society of Local Council Clerks Reminder received that the subscription of £20.00 is overdue. It was decided not to meet this expense this year.

Consultation with Parish Councils concerning Planning Applications A letter from the Chief Planner stated

that as from 1st May it is proposed that Parish/Town Councils should retain the copy of plans forwarded for their comments until after the application has been determined and their copy of the determination notice has been received. Plans should then be returned with any comments on current applications. It is envisaged thay the plans will be returned within 14 days of receiving the notice of determination.

Council Responsibilities A letter from Mr. A. Palliser asked how much the Council has in hand, cash-wise, after paying the Clerk's salary, the Cemetery Superintendent's salary and the £2,000.00 part wages of the footpath sweeper. Sowerby P.C. pays just £500.00. Thirsk should not pay £2,000.00. It is not a public health authority or a highway authority. The Street Sweeper's wages should be paid out of the general rate, which would leave the Town Council with £2,000.00 to spend on Thirsk. It was agreed to reply stating that the Clerk's salary, the Cemetery Supt's salary and the part wages of the Street Sweeper are all considered to be necessary payments. Mr. Palliser was a member of the Council when the street sweeping percentage charge was accepted. If the Town Council refuses to pay its contribution towards the cost of street sweeping, it will be added onto the Parish Rate by the District Council. Sowerby P.C.'s payment last year was low due to the fact that they had overpaid in the previous year. Also Sowerby's hours of street sweeping are far less than Thirsk's and they do not have to bear the cost of the Market Place.

Market Place A letter from the Secretary of the Chamber of Trade stated that on Sunday, 18th May, a hot dog salesman and an ice cream salesman were engaged in retailing on the Market Place. The police were unable to take any action to prevent this. The Chamber of Trade feared that a small Sunday market could develop on the cobbles and asked for the Town Council's assistance in dealing with the matter. Coun. Craig told the meeting that he was aware of the situation and had taken up the matter with the Environmental Health Department of the H.D.C.

Minutes of a Meeting of Thirsk Town Council, held in the Court House on Monday, 16th June 1986 at 7.30 p.m.

Present Couns. H. D. Craig (Chairman), J. J. Allenby, Miss J. Foxton, Mrs. F. M. Roberts, D. E. Loveden, A. J. Davison, J. Brannon, F. N. Bickers, E. R. Stott. Apologies for Absence received from Coun. D. S. Murkett.

Minutes The Minutes of the previous meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Roberts, sec. Coun. Loveden.

Matters Arising from the Minutes

Members had met with a representative of R.A.O.B. Cliffe Top Lodge and agreed upon a site on the verge between the Millgate Car Park road and The Marrage. Permission has to be obtained from Hambleton District Council who own the verge. The Chairman is to meet an officer of H.D.C. on site before approval is given. It is anticipated that this Council will have to meet the cost of fixing the seat and for concrete slabs to be placed in front of it. It was reported that the seat, previously moved from Stockton Road, is now back in place.

Coach Parking The requested site meeting is to take place at 10.30 a.m. on Tuesday, 17th June.

At the meeting with representatives of the Yorkshire Water Authority and the Cod Beck Drainage Board it had been agreed that some properties subject to drainage rates should not be. Mr. Rukin of the Y.W.A. told the meeting that under the Land Drainage Act 1976 s.68(4), the Drainage Board could exempt certain persons from drainage rates and the Water Authority would recommend that this action be taken. There would still be 30 Thirsk properties within the drainage area that could not be exempt and the Drainage Board would be acting illegally if they did so, not matter how small the rate. The only means by which these properties could be de-rated would be for the Hambleton District Council to enter into a Section 81 agreement with the Water Authority and be responsible for the rate but they had always refused. Col. Consett, Chairman of the Drainage Board and a District Councillor, told the meeting that he would raise the matter again with H.D.C.

Town Clock The grant of £307 00 had been received from Hambleton District Council.

Conservation Area Enhancement Schemes Letter presented from Mr. A. D. Robinson of the H.D.C. Planning Department, who had met with Coun. Foxton to discuss the scheme for the Cod Beck Footpaths. Mr. Robinson had also met a representative of the Yorkshire Water Authority and been told that the Authority require a 6 metre wide strip from the river bank to be kept largely free from obstacles such as newly planted trees and fences so to allow a wneeled machine access to the bankside. Existing waterside trees and other features can be retained. The existing footpath from the wier to Stockton Road is badly in need of repair at its western end and should be treated as priority but it lies outside the Conservation Area and is not eligable for CAPE funding. South of the wier there is considerable bank undercutting. Construction of a more permanent path to replace the existing trodden way would create problems if undercutting took place and it was felt that perhaps this section should remain in its present state, although the Water Authority would raise no objections if the Town Council wanted to improve this path with a gravel or similar topping. Coun. Foxton told the meeting that she is to meet a representative of the British Trust for Conservation Volunteers to discuss the scheme and will report on its outcome.

Six baskets of artificial flowers had been supplied and are in place on the Council's lamp standards on the south side of the Market Place. A letter from Mr. Paul Turner, who is not charging for his labour, gave details of the work carried out on the White Mare Roundabout and the bushes and bedding plants along with fertiliser and mulch purchased at a cost of £172.67 to date. Mr. Turner also stated that in his opinion further mulch is required and this will cost between £45.88 and £56.88 depending on how much is needed. The total outlay will at most be £229.55 and that includes sufficient plants, fertiliser and mulch for the troughs in the Market Place. Members agreed that the further expenditure on mulch should be allowed. The Clerk told the meeting that a cheque for £70.00, towards the cost of maintaining the roundabout, had been received from the North Y rkshire County Council.

Road - Little Green It was agreed to enquire of H.D.C. if the planning application by F. D. Todd & Sons for residential development to the rear of 70.

Tree - Stockton Road

A copy letter from the County Area Surveyor to Mrs. Elliott stated that he has now received the necessary information from the Statutory Undertakers regarding their apparatus within the verge affected. He also stated that he would be happy to meet Mrs. Elliott and a representative of the Town Council to agree a suitable position for the siting of a tree within the highway verge. After such a meeting has been held, a formal letter of approval will be sent to the Town Council setting out the conditions of approval. Coun. Roberts reported that she had met with Mrs. Elliott and the County Area Surveyor's representative and because of the amount of apparatus underneath the verge it had been agreed that representatives of the Statutory Undertakers should be invited to a site meeting in order to pinpoint the exact location of their apparatus so that a suitable site for the tree can be agreed upon.

Public Payphones It was noted that the new Public Payphones have been installed at the west side of the public conveniences in the Market Place.

Footpath - Station Road

A letter from the County Surveyor stated that he notes the criticism regarding extension to the footpath on the south side of Station Road and has asked the Area Surveyor to look into the matter and respond direct to the Town Council in due course.

Encroachment at Whitelass

Nothing further was reported on this matter. Coun. Roberts stated that residents of the Shire Park houses that front onto Stockton Road are contravening the planning conditions by making unauthorised accesses through the hedge. It was agreed to draw the attention of the H.D.C.'s Enforcement Officer to this.

Planning Application - A. B. Rose Nothing reported.

Street Sweeping Review Nothing reported.

A further letter from the Chief Executive H.D.C. Public Conveniences - Market Place stated that the concern expressed by the Town Council and Dr. Harrison has now been discussed by the Environmental Health and Control Commmittee. The Committee accepted that the conveniences are not altogether satisfactory and that underground conveniences are quite unsuitable for the disabled, but it could not agree that they are a health hazard and unhygienic. The conveniences were decorated throughout in 1985 and additional ventilation was provided in the Male Section. Coin-operated locks have been fitted in both the Male and Female Sections (except for one night cubicle in each Section) to give an improved standard. It is not denied that letters of complaint are received from time to time from both residents and visitors but recent inspections have revealed a satisfactory condition of cleanliness, though there is the continual problem of graffiti. The facilities are, however, conveniently situated for the bus parking area and particularly for long distance coaches and many views have been expressed that the conveniences provided at Millgate Car Park are too far away for use by passengers of the many buses and coacnes which stop in the Market Place. The Committee has therefore concluded that as the circumstances now existing are no different from those which were current when the matter was last considered, that neither the closure nor the demolition of the conveniences should be entertained at the present time, particularly having regard to the requirements of visitors and residents alike in the central area of Thirsk. However, the Committee has suggested that when cleaning is undertaken, special efforts should be made to achieve a situation which will leave the conveniences in a much drier condition than is the usual practice and these comments will be passed on to the cleaners concerned. Coun. Craig, who is a member of the H.D.C. Environmental Health & Control Committee, stated that he was not present at that meeting but will take up the matter with the full Council, and request a deferment of their decision. It was agreed to accept Coun. Davison's suggestion that the Health and Safety Executive and Factory Inspectorate be asked to carry out a survey on the public conveniences in the Market Place.

Heavy Lorries through Thirsk A letter from the County Surveyor stated that the HGV origin and destination surveys, which were promised, will be carried out in early June. When the results of the survey have been collated and analysed he will be in a position to report more fully on the possibilities of implementing some form of control on heavy commercial vehicles travelling through the town.

Footpath - Cemetery to Newsham Road Coun. Brannon reported that this footpath is very overgrown.

Kerb Coun. Bickers reported a loose kerb on the corner of Bridge Street/St. James' Green.

Drain Coun. Bickers reported a blocked drain on the Little Green road.

Station Road Coun. Loveden stated that the surface of Station Road is very uneven following reinstatement after the laying of a new gas main.

Sutton Road Coun. Allenby reported that motorists are disregarding the speed limit when travelling towards White Mare Corner. This matter to be referred to the Police Traffic Section.

Mill Gardens Coun. Foxton requested a working party to tidy the Mill Gardens. The Chairman, Coun. Roberts, Coun. Davison, Coun. Loveden and the Clerk volunteered.

Ruboish - Market Place It was agreed to ask the Environmental Health Department to take action regarding the smell from rubbish outside Nelson's fruit and fish shop in the Market Place.

Minutes The Minutes of the previous meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Stott, sec. Coun. Davison.

Matters Arising from the Minutes

The Chairman told the meeting that permission has been granted for the siting the R.A.O.B. seat on the Car Park verge, facing Biggins Hill. The Clerk reported that the insurance claim for repairs to the damaged seat outside 'Mind' has been settled.

Coach Parking Members were referred to the meeting of 17th June, held to discuss the lack of suitable coach parking facilities in Thirsk, and attended by Mr. Adams and Mr. Robinson of the Chief Planner & Technical Officers department, Mr. Cressey and Mr. Barker of the County Surveyors department, a representative of the Police, Coun. Mrs. M. Potter H.D.C., and members of the Town Council. Proposals to be put to the Hambleton District Council were made as follows: 1. The small Car Park should be designated for coach parking as a temporary measure. 2. The wide grassed verge between the road and the large Car Park should be removed and the area designated for coach parking in accordance with a plan presented by the Police. It was understood that funds are not available in the present financial year for the latter proposal but a request was made for provision to be made in the future. A proposal was made to put to the County Council that the road through the Car Park should be made 'one way', which would allow the parking of coaches at the roadside. A letter from the County Surveyor stated that arrangements have been made for traffic counts to be carried out on the pertinent section of the Millgate Car Park access road in the next few weeks. This will enable an assessment to be made of the amount of traffic which will be re-distributed around the toen centre if a one-way system were to be introduced. A reply from the Hambleton District Council is awaited.

Cod Beck Drainage Rates Nothing reported.

Conservation Area Enhancement Scheme Nothing reported.

White Mare Roundabout The Clerk told the meeting that Mr. Paul Turner had notified her that despite being of very good quality and having been watered regularly, most of the plants had died or were dying. He had sent soil samples for tests in order to determine the cause. Coun. Murkett suggested that the roundabout should be 'flagged' with small areas left for the planting of hardy shrubs. It was agreed to await the results of the soil analysis.

Road - Little Green A letter from the Chief Planner H.D.C. stated that the Planning Committee had resolved to grant planning permission for the proposed residential development on land to the rear of 70, The Green for F. D. Todd & Sons subject to the views of the County Surveyor. There remain unresolved matters between the applicants and the County Area Surveyor and until such time as these have been settled the application cannot be determined. If the matters remain unresolved the application will need to be referred back to the Planning Committee for further consideration.

Tree - Stockton Road Nothing recorted.

A letter from the County Area Surveyor stated that the extension of the existing footway which runs along the south side of Station Road to cover the frontages of the very large and established industrial sites owned by Grunta Products and Austin Reed had been on the list of new footway proposals for some time. The road is both wide and busy at this location and the purpose of the footway extension was to minimise the need for pedestrians to cross and re-cross the road here. In addition to those living in the vicinity who would use the footway, consideration was being given to the employees and customers of the two industrial sites. There were no objections of any kind to the new footway from either Sowerby or Carlton Miniott Parish Councils and prior to the start of the work

Footpath - Station Road - cont. Coun. Murkett stated that the extension would have been acceptable if it had joined up with the path at the Red House, but there is a gap of 150 - 200 yands and it is more dangerous to cross the road there, because of the bend, than where the footpath ended previously. It was agreed to request the County Council to take whatever steps are required to extend the footpath as far as the Red House.

Encroachment at Whitelass and Stockton Road A letter from the Chief Planning Officer stated that the Enforcement Officer will investigate the encroachment at Shire Park and reply in due course. Coun. Roberts reported that Shire Road has not yet been properly surfaced, kerbing has not been completed and the boundary hedge at No. 2, Shire Road, removed by the developers, has not been replaced. These matters to be brought to the attention of the Planning Dept.

Planning Application - A. B. Rose Notification received that planning permission has been granted.

Street Sweeping Review Nothing reported.

Public Conveniences - Market Place The Clerk told members that the Health and Safety Executive and Factory Inspectorate is not the body to ask to carry out an inspection of the conveniences and advice had been sought from the Yorkshire L.C.A. A letter from the Assistant Secretary stated that he is not aware of any advisory body who may assist but suggested that the Council contact the Local Medical Officer of health who is normally a local doctor. If his opinion is in agreement with the Town Council's views, then it may be that the conveniences constitute a 'statutory nuisance' within Section 92 of the Public Health Act 1936. Should it appear that there is a statutory nuisance, the Council has poer to make a complaint to the magistrates against the District Council. It was agreed to ask the Local Medical Officer of dealth to carry out an inspection of the conveniences. The Chairman and Coun. Murkett agreed to raise the matter of the public conveniences at the next Hambleton District Full Council meeting. Members were concerned that all the conveniences, with the exception of one male and one female section cubicle in the Market Place conveniences, are closed at 6.30 p.m. each evening. It was considered essential that all the facilities should be available in the evenings for the benefit of visitors to the town. It was agreed to make a request to H.D.C. that all the conveniences remain oven until 10.00 p.m. and surgest that they could be locked by the person who is employed to lock the Car Park barrier.

Heavy Lorries through Thirsk Nothing reported.

Seats - Ingramgate The Clerk reported that 3 seats have been ordered from Albert Jeffray with delivery expected in September. Reply awaited from N.Y.C.C. regarding siting the seats.

Following a meeting attended by Coun. Roberts, the Clerk and two members of Sowerby P. C. the Municipal Mutual Insurance Fire Surveyor carried out a valuation of the Town Hall and the opinion of the Insurance Company is that a figure of £266,426 should be placed on the Building for Insurance purposes. It was stressed that this figure is only a suggested amount and the Sum Insured on the building must be the decision of the Committee as the Company cannot be held responsible should the suggested amount prove to be inadequate in the future. The sum insured of £266,426 is the current re-building cost of the property (New for Old basis) and includes cover for removal of debris and Architects and Surveyors fees. The premium at the moment is £200,00 and if the Committee eventually decided to increase the Sum insured to the suggested figure then the yearly premium would increase by £66.43 to £266.43 per annum. It was agreed that the cover should be increased in November when the premium is due but if Sowerby P. C., as co-owners, wish it, the cover should be increased immediately.

St. Mary's Walk Members agreed to inspect the site and report to the next meeting.

Audit - Investment The Clerk had received information regarding National Savings Investment Accounts which require 28 days notice of withdrawals. It was felt that this could cause problems as money would not be readily available. It was considered that possibly an account could be opened when the Precept is received with a balance also being kept in the Building Society.

Highway Matters A letter from the Divisional Surveyor referred to the following:

Footpath - Cemetery to Newsham Road As soon as the N.Y.J.C. are on top of their grass cutting activities the overgrown footpath will be attended to.

Kerb The kerb in St. James' Green will be dealt with shortly.

Station Road The trench in Station Road is included in a contract for reinstatement to commence very shortly. In the meantime, NEGAS have been requested to ensure that the trench is maintained in a safe condition.

Speeding - Sutton Road A letter from the Chief Superintendent of Police stated that arrangements have been made for speed checks to be carried out. It pointed out that often the nature and character of the road distorts the speed at which vehicles are travelling and the perceived speed appears greater than the actual speed. Demands on the police to enforce speed limits have increased in recent years due to the introduction of many new speed limits and the level of attention which can be given to particular complaints of this nature have to be balanced against demands as a whole. Officers will however, carry out speed checks in the area as and when resources are available.

Mill Gardens
The Chairman praised the efforts of Coun. Foxton, Coun. Roberts, the Clerk and Mrs. Margett in tidying up Mill Gardens. Coun. Foxton told members that there is still work to be done and more shrubs are required. Coun. Roberts agreed to obtain a shrub catalogue. The Chairman reported that the flower troughs in the Market Place and been repaired and re-planted. The troughs around Hambleton District Council's trees have been cleared out.

Supermarket Sites The exhibition in the Town Hall had attracted 1400 people, 940 of whom completed questionnaires with 855 in favour of a new supermarket. 401 members of the public favoured the Bamlett site, 218 the Long Street sites and 167 for The Nurseries. There was also a petition of 1400 signatures against The Nurseries site. The H.D.C. Planning Committee on a 12 - 6 majority resolved to accept the Bamlett site and the A.T.S. site on long Street and reject The Nurseries. The full Council of H.D.C. overturned the Planning Committee's decision on a 20 - 11 vote with one third of the members absent.

Notice of Motion - Coun. Roberts Prop. Coun. Roberts, sec. Coun. Foxton 'This Council should inform Hambleton District Council that it is dismayed at the decision taken regarding supermarket sites.' Coun. Roberts stated that this Council is appalled and dismayed at the decision taken by H.D.C. regarding the siting of supermarkets in Thirsk. Javing staged an exhibition and asking for the public's opinion, which opinion was endorsed by the Planning Committee. The whole Council then reversed the Planning Committee's decision and totally ignored the wishes of the people of Thirsk. The Planning Committee voted for what the people wanted and for the whole Council to go against that decision brings the whole idea of Local Government into disrepute.

A letter from Mr. A. Palliser referred to a letter to the Press from Mr. J. Bell who suggested that the people of Thirsk and Sowerby should make their opinions known by writing to the Secretary of State for the Environment. A letter from Mrs. V. Margett expressed concern over the recent planning approval by Hambleton District Council for a supermarket to be built on The Nurseries site. It was noted that Coun. Craig, as a District Councillor, had voted against The Nurseries site and Coun. Murkett in favour. All the members present, with the exception of Coun. Nurkett, were against the siting of a supermarket at The Nurseries. Coun. Brannon stated that there should be a public enquiry. On an amendment to the motion - Prop. Coun. Brannon, sec. Coun. Allenby 'That there should be a public enquiry so that the public can express their opinions'. Voting - in Favour of the Amendment - 5. In Favour of the Motion - 4. Amendment carried.

A request to be sent to the Secretary of State for the Environment for a Public Enquiry.

J.C. referred to the unscheduled visit and stated that the District Council connot accept the Town Council's assertion that the public conveniences are unhygienic. Memoers commented that the improved conditions were due to the publicity in the press. It was noted that paidting had recently been carried out. It was agreed to reply pointing out these facts and to request that the exterior be painted, the interior modernised and adequate funds available for supplies of cleaning, disinfecting and toilet materials. 140 C

Supermarket Sites

A letter from the Department of the Environment stated that the responsibility for the administration of normal day-to-day planning control rests with Hambleton District Council, as the democratically elected L.P.A. It is the general policy of the Decretary of State not to interfere in the exercise of these responsibilities unless matters of regional or national importance are involved. The Secretary of State has given careful consideration to the request for a public inquiry but on the information available he has decided that this would appear to concern local issues only and is not a case which he would wish to remove from the jurisdiction of the L.P.A. If it is considered that injustice has been caused by maladministration within the Council then the matter can be raised with the local ombudsman who will investigate the complaint. It was decided that this is not a matter for the ombudsman. Prop. Coun. Roberts, sec. Coun. loveden 'that the Chief Executive 1.D.C. be asked to come and discuss the District Council's decision on supermarket sites with this Council and Sowerby Parish Council'. Agreed.

Market Place A letter from the Divisional Surveyor stated that repairs will be carried out to the surro ands of the lighting columns in the near future.

Garden - Little Green Nothing recorted.

Meeting with Hambleton District Council Officers A meeting had taken place on Monday, 4th August with the Chief Environmental Health Officer, the Cleansing Officer, The Principal Technical Officer and the Market Superintendent. Subjects discussed were the Markets and Litter, the general Litter problem, Street Sweeping and the Public Conveniences. A letter from the C.E.H.O. stated that the Market Superintendent has an extremely difficult job in keeping a balance between being fair with regard to the implementation of the Market Trading Conditions and Byelaws and keeping on good terms with the Market Traders. With regard to the 3' gap between stalls and the footpath, the possibility of a white line being painted on the Market Place will be investigated. Investigations will also take place into the possibility of burchasing plastic cards for display on stalls giving details of name, town of origin etc. of stallholders. Idntification of the Market Superintendent presents a problem in that it presents a security risk and it is suggested that a letter box be added to the Superintendent's but in case of any enquiries or queries being made in his absence. The cleansing of the Market Area is undertaken by three Environmental Health Dept. employees although some litter is inevitably trapped beneath parked cars. The answer as far as the weekend litter is concerned is to reintroduce weekend sweeping, Sunday A.M. at least. This matter will have to be dealt with by the Chief Planning and Technical Officer. A letter from the Principal Technical Officer stated that the Council is looking into alternative ways of making the bus shelter as vandal-proof as possible, but before any decision is made he would be grateful for the Town Council's opinion on the matter. He would also be bleased to know if the Town Council would be willing to take over future maintenance of the bus shelter and what works would be required before doing so. Prop. Coun. Foxton, sec. Coun. Allenby 'that the present bus shelter should be replaced with a prick structure facing the barket Place'. Agreed. Members agreed that the Town Council will not accept responsibility for future maintenance at the present time.

White Mare Roundabout Mr. Woods attended the meeting to discuss the roundabout. He told members that total weed killer had been used to remove weed growth after the cotoneasters were removed two years ago and none had been used since that time. It was possible for faint traces to remain for up to twelve months. A supply of new soil had been put on the roundabout and at a later date ammonium sulphate had been added to reduce the ph content which was thought to have been one of the causes for the failure of the plants in 1985. Mr. Moods stated that there are plans to resurface the road at the roundabout and some kerbing will be involved. He offered to have all the soil removed from the roundabout and replaced with a new supply, to cover it with a thick plastic sheet to deter weed growth, followed by a layer of gravel. Small slits would be made in the gravel to enable the planting of low shrubs. the Cod Beck Internal Drainage Board has agreed to make an
Exemption Order for properties in the Barbeck area and the new estate on Stockton Road,
both of which lie within the Drainage District but warrant exemption from rates in view
of the height of the properties above the highest recorded flood level in Cod Beck. The
Exemption Order will benefit many of the petitioners but others, for example in Finkle
Street, are quite properly within the Drainage District and below the highest flood
contour and therefore, will remain liable to a Drainage Rate as determined by the Board.

Conservation Area Enhancement Schemes Coun. Foxton told the meeting that she is to meet a representative of the British Trust Conservation Volunteers to look at the scheme for The Holmes.

Road - Little Green Reply still awaited from the Planning Officer. It was understood that the Principal Technical Officer is arranging to have the road outside No. 89, The Green repaired.

Tree - Stockton Road Mothing reported.

Encroachment at Stockton Road Reply from Planning Department still awaited.

Street Sweeping Review Nothing reported.

Public Conveniences - Market Place It was reported that £20,000.00 has been allocated for modernising and refurbishing the conveniences.

Heavy Lorries through Thirsk Nothing reported. Coun. Davison expressed concern that when the A1/Baldersby flyover is completed, traffic will be directed via the A61 through Thirsk to the A19 instead of using the by-pass. This to be brought to the attention of the County Surveyor.

Seats - Ingramgate The Clerk told the meeting that the seats have been completed and will be in place on the sites in Ingramgate, agreed with Mr. Woods, in the very near future.

St. Mary's Walk Mr. Woods agreed to inspect the bath with Coun. Roberts.

Supermarket Sites Reply awaited from the Chief Executive H.D.C.

Bus Shelter The Principal Technical Officer had told the Clerk that it would be very expensive to build a new bus shelter and suggested that a 'see through' type of unbreakable material might be suitable.

Christmas Lights The Chairman told the meeting that a donation of £100.00 has been received from the Chamber of Trade together with the lights. It was agreed to invite local electricians to submit tenders 'to test existing equipment, erect the Christmas Lights on the Town Clock to the Town Council's specification and dismantle after the Christmas period.' Tenders to be received in time for the October meeting. Coun. Loveden agreed to show the equipment to the electricians.

The Holmes Play Equipment The Parallel Bars to be inspected by the sub committee.

Cemetery Water Supply

The Clerk stated that a representative of the Water Authority had suggested that application be made for a new water supply in order for the cost to be assessed. The water meter would not be sited on Council land and it would be necessary for a tranch to be dug for the new pipes to be laid.

Mr. Collinson had indicated that he would be willing to carry out this work. It was agreed to submit an application for a new supply and await notification of the cost.

Ditch - Dowber Way/Hambleton Place

The Principal Technical Officer had told the Clerk that he was considering putting a solid base in the ditch, as discussed with Coun. Craig, and he would ask for the matter to be on the agenda of the next Housing Services Committee meeting. It would not be possible to have the ditch culverted as this was a requirement of the Yorkshire Water Authority, so that it is open in the event of a flood. It was agreed to write to the Y.W.A. asking if it is still necessary for the ditch to remain unculverted.

Thirsk Railway Station A letter from the Acting Area Manager, British Rail, stated that train services at Thirsk are not likely to change significantly in the forseeable future, except for improvements planned for 1987 to put the train service on a regular two hourly basis.

Disc Parking The Principal Technical Officer had told the Clerk that after all the necessary consultations have taken place, it is anticipated that Disc Parking will be in operation in time for Easter 1987.

Road Traffic Regulation Act 1984 - Proposed Amendment to One-Way System, Piper Lane

Letter presented from the Chief Executive N.Y.C.C. stating that the County Council intends to make a Traffic Regulation Order which would have the effect of reducing the length of Piper Lane's existing one-way limit. It was agreed to object on the grounds that the road is too narrow to accommodate two-way traffic. Consideration should also be given to residents of Piper Lane with garages.

COMMENTS ON THE ABOVE APPLICATIONS FROM THIRDE TOWN COUNCIL

Thirsk Town Council is totally opposed to the demolition of any Listed Buildings in connection with supermarket development and to Access/Egress at Finkle Street.

Plan 8164.18 shows a window projecting on the west gable wall of the Chinese Restaurant over the pavement on the access road to the Three Tuns Hotel yard. The pavement at this point is only 2'3" wide and this would be a hazard, causing pedestrians to step off it into a narrow road.

There is no mention of the consecrated ground near the Salem Chapel.

Plan 18 shows the Chinese Restaurant incorporated into the development. Plan 25 shows it in its present state. Clarification is needed.

There is no entry to the yard behind the Nurseries shop. It is understood that there is a mistake on the plan and the boundary of the supermarket should be further from the Nurseries buildings to allow access, as at present, with parking space for cars.

There is only one entrance to the subermarket building and this is as far away as possible from the car park. It would be preferable to also have an entrance near the car park and one near the Finkle Street end.

There is no provision for the disabled and elderly to park even temporarily near the entrance. Not everyone is capable of pushing a trolley from the entrance to the car park.

There does not appear to be any provision for trolley parking.

APPLICATIONS NOS. 2/86/152/0309H/J/K/ - MARKET TOWN PROPERTIES

COMMENTS ON THE ABOVE APPLICATIONS FROM THIRSK TOWN COUNCIL

Thirsk Town Council is totally opposed to the demolition of any Listed Buildings in connection with supermarket development and to Access/Egress at Finkle Street.

The whole building is completely out of character and does not fit in with Thirsk at all. The towers have been likened by many people to searchlight towers on concentration camps and the collonade to the public conveniences in Redcar. The glazed entries to the arcade and the arcade itself are in no way reminiscent of the 'backlands of Thirsk' as stated in Drawing 21.

There is no provision for vehicular access to the Nurseries shop.

A footpath to the Market Place is shown across the Three Tuns yard - this yard is private property and there is no public right of way.

The service yard is too near the Nurseries house, the Three Tuns bedrooms and the office block for noise to be kent out.

There is no indication as to the actual boundary of the site.

Striped brickwork is not in keeping with Thirsk.

The entry towers do not appear to have any function other than for small children to run up and down the spiral staircases, the accumulation of litter and walls for graffiti.

The cafe is not required. The present level of cafe accommodation in Thirsk is sufficient. Several have found that business is falling off even now, due to the number of cafes in the town.

The same comment can be made concerning the shop/office accommodation. There are at present a number of shop premises in Thirsk standing empty and a small development of lock-up shops which were granted planning permission some time ago have yet to be built.

There is no indication as to the height or construction material of the western boundary. There is no indication of the position of the western boundary and no drawing of the western elevation.

Inaccuracies in Plan 813 13 have been corrected in Plan 813 13 B with the exception of the Library, the shape of which is wrong and its alignment to the road incorrect.

The developer appears to be treating the library in very cavalier fashion, moving the parking area away from the building and disregarding the parking area for the disabled.

The access/egress at the Castlegate/westgate junction is too narrow for two vehicles to pass and vehicles frequently mount the pavement at this point.

Vehicles turning right to go into the market loce have to cross a line of traffic on an already busy road and additional traffic would result in more hold-ups.

Traffic leaving those after et crosser the main bedestrian way to Sowerby via the Flatts walk.

Seat - Car Park Verge
The seat has now been officially handed over to the Council. It was reported that vandals have attempted to move it from its base.

Coach Parking

The Chairman told the meeting that a 'Coach' sign is to be erected at the Car Park at the entrance to the area where coaches may park. It was reported that the entrance to the 'Buses Only' area on the Market Place is being blocked by parked cars. It was agreed to invite a police representative to the next meeting to discuss this and any other problems appertaining to the police.

Conservation Area Enhancement Scheme Coun. Foxton reported on a meeting with Conservation Volunteers regarding the Riverside Walk scheme.

A team of Conservation Volunteers from Richmond will start clearing the Whitelass area on 26th October at a possible cost of £25.00 - £35.00 per day. Whitelass is not in the Conservation Area. There is to be a 10 day programme of work on the Waterfall to Iron Bridge footpath at a possible cost of £450.00. It may be necessary to provide some form of accommodation for the Volunteers. The Chairman and Coun. Murkett to make enquiries at 4.D.C. regarding the use of Norby Community Centre for this purpose. It was reported that the Rotary Club would like to be involved with a tree planting scheme.

Road - Little Green Nothing reported on this road. A letter from the Principal Technical Officer in reply to a request for the hole in the road outside

No. 89, The Green to be repaired stated that he understands that the land referred to is for communal use of all the adjacent property owners and does not belong to H.D.C. A reply to be sent repeating the fact that the hole in the road was caused by heavy vehicles during renovations to nearby houses, acquired by the District Council under a Compulsory Purchase Order.

Encroachment at Stockton Road Reply from Planning Department still awaited.

Street Sweeping Review

It was reported that an order has been blaced for a mechanical sweeper.

Heavy Lorries Through Thirsk

The County Surveyor to be asked for the result of the HGV origin and destination surveys which was carried out in June.

Seats - Ingramgate The seats are now in place. The Clerk reported that insurance cover has been arranged for these seats together with the R.A.O.B. seat and increased cover has been obtained for the existing seats. This action was endorsed by the members.

St. Mary's Walk Due to the absence of Coun. Roberts, no information was available.

Bus Shelter A letter from the Principal Technical Officer stated that he will be submitting a report to the Leisure and Amenities Committee regarding the future of the bus shelter. The Committee will be asked to consider the alternatives of repair/replace or remove without replacement the existing bus shelter. A reply to be sent stating that a bus shelter is essential in the Market Place. The Chairman, who is a member of that Committee stated that he will fight for a replacement.

The Holmes Play Equipment Inspection has not yet taken place.

The Holmes The Chairman reported that more damaged trees require attention and he has arranged for this to be done.

Ditch - Dowber Way/Hambleton Place A letter from the Northern Area Engineer Y.W.A. stated that it is his understanding after consulting

the files that it was not a requirement of Yorkshire Water to leave the drain open to act as a storm water storage area. It is on record that they wished the watercourse to be culverted due to the problems associated with open drains in urban areas. However, Barratt Developments felt that this would be too expensive and therefore proposed the existing scheme with its flow reduction and storage and a 400mm diameter pipe. If the watercourse were to be culverted, it would require an 850mm diameter pipe. A letter from the Principal Technical Officer H.D.C. referred to the Y.W.A. letter and stated that allowing the ditch to be culverted with an 850mm diameter pipe is contradictory to what the Authority and its predecessor, the Yorkshire River Authority, have said to the Council in the past. The scheme was first proposed before Local Government reorganisation in 1974 by the then Thirsk Rural District Council. The requirements for the ditch/washland area was identified by the North Riding of Yorkshire County Council and the River Authority to accommodate possible flood water in times of heavy storms. The ditch and adjacent land were the subject of an Appeal in 1979 and the Inspector for the appeal concluded that he agreed that the ditch must be retained for its eventual purpose, which was to act as a water storage area in times of heavy storm. There is no record that the Y.W.A. would accept an \$50mm culvert to replace the ditch, but if they are saying that this is acceptable, the information will be put to the Council's Housing Committee asking if they require the ditch to be filled in. Details will be required from Y.W.A. regarding the adequacy of an 850mm pipe along the Council's section of land. The section of ditch in Barratts ownership cannot be piped by the Council. It was agreed to request the Principal Technical Officer to take the necessary action to have the ditch culverted.

Mill Gardens The new litter bins still awaited. Coun. Foxton stated that more shrubs are required for the gardens.

Mater to fit a new connection in the same trench water to fit a new connection in the same trench as Mr. Collinson's and provide and fit a meter and pit. The cost also includes all necessary excavation and reinstatement in the public highway at Norby. A separate supply would cost £561.00. The Clerk and the Cemetery Sub Committee had met with a Y.W.A. engineer who explained that the meter would be at the edge of the public highway in Norby and the Council would be responsible for taking the supply to Cemetery Lodge. The route for the supply would be across Mr. Collinson's land and Wetlands Lane. A 'wayleave' would be required from Mr. Collinson and permission from Thirsk Hall Estate with regard to Wetlands Lane. Mr. Collinson agreed to obtain a quotation for the supply and laying of the pipe from Norby to Cemetery Lodge. Prop. Coun. Loveden, sec. Coun. Allenby 'to accept the quotation of £416.16' Agreed. Prop. Coun. Murkett, sec. Coun. Loveden 'that the Chairman be given authority to accept a quotation for the supply to be taken across to Cemetery Lodge'. Agreed.

Christmas Lights A letter from Mrs. Monica Loveden of 'Down To Earth Healthfoods' in Chapel Street offered a sum of money towards the Christmas Lights equal to the energy cost of the 1985 decorations. This offer was gratefully accepted. The Clerk reported that 5 local electricians had been contacted and only 1 had submitted a quotation.

To supply 50 metres of cable, 140 coloured lamps and 1 isolator switch + Labour \$240.00 + V.A.T.

Prop. Coun. Murkett, sec. Coun. Allenby 'that this quotation submitted by Mr. Guy Johnston be accepted.' Agreed.

Mr. Johnston pointed out that the North Eastern Electricity Board had requested that an Isolator Switch be provided inside the clock.

Mr. Johnston also pointed out that on the grounds of Health and Safety, N.E.E.B. will not accept the cable feeding the lights coming through the old fountain entrance. It must be higher up the clock tower out of reach of the general public. The quotation does not include drilling the stonework.

It was agreed to ask Mr. Collinson if he will drill the necessary hole.

Following the exemption from Drainage Rates of properties in the Drainage District but above the highest recorded flood level of Cod Beck, Coun. Loveden stated that the remaining ratepayers, with properties below the highest flood contour should also be relieved from that burden. These ratepayers, in Bridge Street, Finkle Street and The Green pay a total of approximately £178.00 per year. Prop. Coun. Loveden, sec. Coun. Murkett 'that Hambleton District Council be asked to absorb the Cod Beck Drainage Rate in the same way as other District Councils do in their areas.' Agreed

Disc Parking The Hambleton District Council's scheme for Disc Parking was presented for comment. Members were in agreement with the scheme but were totally opposed to areas of the cobbles being designated for the placing of tables and chairs. The area in front of 85 - 89, Market Place should be a 'No Parking' zone in the interests of public safety. Vehicles parking on the area to the west of the Post Office should be prohibited from being driven on or off by way of the area reserved for Public Service Vehicles. It was suggested that the parking places could be marked with studs in preference to white lines.

Correspondence

National Key Scheme for Toilets for Disabled People

Planner & Technical Officer H.D.C.

stating that this scheme will operate from 1st October. A spare key can be obtained from the Three Tuns Hotel and a notice will be displayed at the toilet block with this information. Keys, at a cost of £2.50 each, can be purchased from the H.D.C. Planning and Technical Department at Stone Cross, Northallerton.

Seat - Barclays Bank Letter presented from the Manager, Barclays Bank, referring to the Council's decision to resite all seats outside banking premises in the interests of security. One seat, which has now been daubed with a white solution, still remains outside Barclays Bank. The Manager would be grateful for assurance that the Council's decision will be implemented without delay. It was agreed to look for an alternative site on the south side of the Market Place.

Thirsk Parish Church Restoration Appeal

Letter presented from the Appeal Director stating that he had previously been told that the Council felt that they supported the Church as much as they were able through the annual grant for graveyard maintenance but that he understood that the Chairman is prepared to raise the matter again in the hope of now gaining some support. The Appeal Fund is still £17,000 short of its target. Members were of the opinion that further support could not be given. It was pointed out that this year's grant towards the upkeep of the churchyard has not yet been made. Prop. Coun. Murkett, sec. Coun. Allenby 'to forward the £200.00 so that it can be allocated to either churchyard maintenance or the Appeal Fund'. Agreed.

Thirsk & Sowerby Liberal Group Letter presented from the Chairman of the newly formed group regarding the following matters about which he has written to the Hambleton District Council: 1. Traffic problems and in particular a suggestion for a speedy implementation of a disc parking scheme on the Market Place and provision of parking facilities for tourist coaches. 2. Opposition to a supermarket on The Nurseries site. 3. The problem of litter and the Market Blace toilets. It was agreed to reply stating that all these matters have already been taken up with H.D.C. on many occasions.

Revenue Estimates Letter from the Treasurer H.D.C. stating that he requires this Council's revenue estimates no later than 28th November. The product of 1p rate for 1987/88 is estimated at £3,700.00.

Recreation Land - Hambleton Estate

A copy of a letter from the Community Care Association
to the Chief Executive H.D.C. expressed concern that
no land has yet been acquired for recreation purposes at Hambleton Estate. A copy memo
from the Chief Executive to the Chief Planner & Technical Officer stated that he has

Minutes The Minutes of the previous meeting having been circulated and approved, were signed by the Chairman. Prop. Coun. Stott, sec. Coun. Roberts.

Bus Shelter The Chairman told the meeting that he had been informed by the H.D.C.'s Treasurer that maintenance should have been charged to the Town Council.

Mr. Starling accepted that the bus shelter is most unsatisfactory as part of a conservation area. Its present state, with 36 broken panes, is a disgrace but to install vandalproof glass would be very expensive. It is the only bus shelter maintained by the District Council and the Leisure and Amenities Committee are not in favour of H.D.C. paying for a bus shelter primarily for Thirsk. It will be brought up to a reasonable standard if the Town Council will then undertake to maintain it. The alternative would be to have it removed.

Coun. Murkett stated that the District Council has accepted responsibility for 12 years and cannot opt out now. A large profit is made from the Market Place and the bus shelter is used mainly by people from the hinterland and not by residents of Thirsk and Sowerby. The bus shelter stands on H.D.C. land.

Goun. Roberts asked what works H.D.C. are prepared to do, suggesting that the front wall be bricked up to eye level. Mr. Starling replied that the shelter would be handed over fully glazed and decorated. To brick up the front wall would not be viable and such work goes beyond maintenance and repair. If a new shelter is required, the Leisure and Amenities Committee would refuse.

Reglazing was not acceptable to members as it would be vandalised immediately.

Mr. Johnson told the meeting that the H.D.C. are acting as agents regarding the bus shelter which belongs to the Town Council and wish to teminate the agency.

Prop. Goun. Murkett, sec. Coun. Foxton 'that this Council takes no action and does not accept responsibility.' Agreed.

Disc Parking Mr. Johnson explained the Thirsk (Off-Street Parking Places) Order 1986 to the meeting, pointing out that the Town Council's suggestion of No Parking in front of 85 - 89, Market Place had been implemented. Timber bollards are to be erected to prevent vehicles, parked on the area at the west end of the Post Office, from being driven over the Public Service Vehicles area. Regarding the areas outside The Golden Fleece and The Royal, designated for the placing of tables and chairs during the summer months, all cafe, hotel and public house owners had been approached and these were the only ones requesting the facility. It is for a trial period and subject to a 7 day licence. There are no licensed taxis in Hambleton District at the present time and no specific provision will be made for taxi parking until it is proved to be required. Firms in the area have private hire vehicles with no right to ply for trade on the Market Place. Parking of cars can be done in blocks and it is not necessary for individual bays to be marked out. A recommendation is going before the Personnel Sub Committee for the employment of Car Park Enforcement Officers who would operate 6 days weekly. It is anticipated that Disc Parking will be introduced on 16th April 1987 in time for Easter and in the new financial year. Members made the following observations on the proposals: Cars parked at the front of

Members made the following observations on the proposals: Cars parked at the front of the Royal Oak should be at an angle. An access from the road at the east side of the Golden Fleece is unnecessary. Car parking should be permitted facing the foetpath at the front of 28 - 38, Market Place, an area not designated on the plan for parking.

Asked about the future maintenance of the cobbles, Mr. Starling stated that the Market Place surface is unsatisfactory and costly to maintain and it may be necessary to discuss its future with the previous owner.

Grounds for Appeal

1. The unit for the proposed pizza take-away will be designed to fit in with adjoining units and the shop front fitted with a Victorian style bay window and door and in keeping with the era of the building.

2. It is hoped to encourage a wide range of people, both local and tourists to whom can be offered an alternative hot food take-away. Market research shows that the food to be offered is very much in demand by all generations and the nearest pizza take-away is at Northallerton. A local delivery service will be offered. 3. There will be only limited smell from the pizza ovens which will be counteracted by means of an adequate ventilation system. 4. Most of the packaging will be large and bulky which will probably be taken home. In order to help prevent the litter problem in the Market Place a member of staff will be delegated at regular intervals to collect any litter belonging to the proposed pizza take-away and litter bins will be provided inside and outside the premises.

The District Council, apparently, agreed to act as agent in maintaining the shelter and the position is now that it wishes to terminate that agency agreement, taking the view that the shelter is provided for the benefit of Thirsk people rather than residents in the district as a whole, and accordingly the cost of its maintenance should be borne by Thirsk rate-payers. The Community Care Association, in conjunction with the East Thirsk Community Association have approached the District Council with a view to securing the provision of part of the site for the purposes of constructing a community centre, utilising the grants that may be available. Where such a venture is to be provided, it would appear that the Town Council would need to sub-let the land to the Community Association and then enter into some appropriate arrangement with the District Council for the financial implications to be considered.

Recreation Land cont/

Prior to the acquisition of the land, the Town Council is asked to confirm that it would be willing to enter into a 99 year lease and to execute any relevant works upon the land to ensure that it is properly laid out as a playing field. It was agreed to request that the District Council implement the procedures as soon as possible to obtain the land by Compulsory Purchase. The Town Council is willing to enter into a 99 year lease and to carry out any relevant works it considers necessary. With regard to land for a site as a community hall, Coun. Foxton stated that there is no need for a hall. Coun. Murkett had suggested that the E.T.C.A. should use the facilities at the Primary School to ascertain if there is such a need. Coun. The Minutes of the previous meeting, having been circulated and approved, were Minutes signed by the Chairman. Prop. Coun. Murkett, sec. Coun. Loveden.

Matters Arising from the Minutes

Bus Shelter Reply from Hambleton District Council awaited. Coun. Murkett told members that the District Council intend to remove the remaining panes of glass, paint the bus shelter and hand it over to the Town Council. Members agreed that the bus shelter is of no value to the Town Council and is used by ratepayers of the district. It was agreed that the Chairman and Coun. Murkett fight the District Council's decision at the next meeting of the full Council. It was decided not to take any action in the event of being forced to assume responsibility for the bus shelter until the proposed alterations to the Post Office have been carried out. It was agreed to ask the Head Postmaster when the work is to be done.

Disc Parking Coun. Murkett reported that 2 part time Car Park Enforcement Officers are to be appointed.

Coach Parking A letter from the County Surveyor stated that traffic counts had been carried out in order to assess the implications of making the north western part of the road through Millgate Car Park one way(in a north westerly direction). Banning entry into the car park from Kirkgate and forcing the traffic to negotiate Kirkgate, Market Place and Millgate before entering the car park from the opposite end could result in the eastbound flow in the Market Place being increased by 20-25%, depending on the day of the week. During the summer tourist season, particularly at weekends, serious congestion is experienced in the Market Place and the one way system, as proposed by the Town Council, would significantly worsen the traffic delays on A61 eastbound through the town centre and on B1448 Kirkgate. It would appear that the extra circulation of traffic through the Market Place is an extremely high price to pay to accommodate, at the most, parking for six coaches. Additionally, restricted waiting requires a continued Police presence which, unfortunately, is not readily available and the Traffic warden coverage at the present time is merely part time. In the circumstances the Police could not support the introduction of a one way system on part of the access road to Millgate car park. It was recommended that in view of the limited number of coaches involved and the potential traffic problems in the Market Place, the proposed one way order and on-street parking order for (part of) the Millgate Car Park access road be not proceeded with. Members were extremely disappointed at this decision. Prop. Coun. Murkett, sec. Coun. Loveden 'to accept the decision of the County Council and to monitor the situation during the summer.' Agreed.

Conservation Area Enhancement Scheme - The Holmes Nothing reported.

Road - Little Green Coun. Murkett had been told by Mr. Todd that he has not yet been informed by the County Council what work has to be done but there had been a suggestion that a first class road with a footpath at either side would be required. It was agreed to ask the County Council to consider a road compatible with the environment in a conservation area and not a public highway.

Encroachment - Stockton Road A letter from the Chief Planner referred to previous correspondence regarding the non-compliance with conditions at the PLC Homes development, and stated that a report was submitted to the January 1987 Planning Committee meeting when Members were advised that having taken legal advice it was considered that as there was no clear indication as to the correct interpretation of the phrase 'access requirements', the wording of the condition was not sufficiently clear to sustain the issue of an Enforcement Notice for breach of condition. It was, therefore, recommended that no further action be taken. It was agreed to reply stating that the Town Council is disgusted at the inefficiency which caused this to happen and suggesting that it is ensured that future planning conditions are enforcemble.

Minutes of a Meeting of Thirsk Town Council, held in the Court House on Monday, 16th March 1987 at 7.45 p.m.

Couns. H. D. Craig (Chairman), D. S. Murkett, D. E. Loveden, A. J. Davison, Present Miss J. Foxton, Mrs. F. M. Roberts, F. N. Bickers, + 2 members of the Public. Apologies for Absence received from Coun. J. Brannon.

The Minutes of the previous meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Loveden, sec. Coun. Murkett.

Matters Arising from the Minutes

Bus Shelter Confirmation still awaited of the District Council's intentions regarding the bus shelter. Members were of the opinion that removing the remaining glass and painting the shelter prior to handing it over to the Town Council is not acceptable. Various options were considered - demolition of the existing shelter and eventual replacement with a modern vandalproof structure or renovation until funds are available for a new structure, were discussed. It was also suggested that there could be a centre opening in the existing shelter with both ends blocked up. Coun. Davison produced a sample of unbreakable material which could be used for window replacement. It was agreed not to take action until the Post Office's intentions are known. from the Head Postmaster still awaited.

Disc Parking Letter presented from the Chief Executive H.D.C. stating that the Thirsk (Off Street Parking Places) Order 1987 has been made, and pointing out that provision on the Market Place for the siting of tables and chairs has been deleted. A further letter confirmed that Car Park Supervising Officers will be appointed who would not merely be acting to enforce the Order with a view to prosecuting in the first instance but would, ideally, be used for directional or guidance purposes by motorists, seeking to ensure effective regulation over the Market Place, but would also act as a point of reference to any incoming tourists seeking particular advice about Thirsk and

Coun. Roberts expressed concern about Clause 21C of the Order regarding eating in parked vehicles.

Coach Parking The Chairman produced letters from the Chamber of Trade, John Smiths Coaches and George Bell Travel, regarding the effect on the town's trade if tourist coaches stop visiting Thirsk because of the lack of coach parking facilities. The Chairman was of the opinion that the small car park in Millgate would be suitable for coaches. Coun. Murkett stated that coaches on that area would disturb the elderly residents of Gillings Court. Members agreed that the grass at the Millgate entrance to the Car Park should be used for coach parking as suggested by the Police but turned down by the District Council because of the cost. The Chairman to press for this at the Leisure and Amenities Committee meeting. Members also felt that the road through the Car Park could have been made one-way, for a trial period, to allow roadside parking of coaches. County Councillor Turton to be asked to attend the April meeting to discuss this.

Concervation Area Enhancement Scheme - The Holmes Nothing reported.

Road - Little Green A letter from the County Area Surveyor stated that the planning application by F. D. Todd & Sons for residential development at the rear of 70, The Green has been refused for the following reasons: 1. The L.P.A. considers that the roads leading to the site are not of a sufficient width or suitable construction and layout to cater for any traffic which would be likely to be generated by this proposal. 2. It is the policy of the County Council that where a street is to be developed to serve four or more properties it shall be laid out to a standard fit for adoption as a highway maintainable at public expense. The 'street's leading to the site have not been included as part of this application and the layout of the proposed site does not demonstrate a suitable form. The letter continued that details of the adoptable road necessitated by this development has yet to be agreed and any registered land which may be required for provision of this access road must firstly be deregistered by request of the applicant. Members considered that a meeting of all the parties concerned could be advantageous to Todds but it was agreed to ask County Councillor Turton to discuss the highway aspect at the April meeting.

Street Sweeping Review It was reported that the mechanical sweeper is now in use.

Heavy Goods Vehicles through Thirsk Nothing reported.

St. Mary's Walk Coun. Roberts to meet Mr. Woods in the near future.

Encroachment at Stockton Road A letter addressed to Coun. Murkett, from a resident of Whitelass Close who was at the meeting, was presented.

The writer requested, for security reasons, that its contents should not be reported by the Press. This was not acceptable to the Press. Prop. Coun. Murkett, sec. Coun. Roberts 'that the Council go into Committee to discuss a matter of confidentiality, security and not being in the public interest.' Voting - 6 in Favour - 1 Against. The members of the Press left the meeting.

It was agreed to forward the letter to the Chief Planner H.D.C. and request that the Enforcement Officer insists that the gaps in the hedge are blocked.
