Minutes of a Meeting of Thirsk Town Council, held in the Court House on Monday, 13th April 1987 at 7.00 p.m.

Couns. Miss J. Foxton, D. S. Murkett, D. E. Loveden, J. Brannon, A. J. Davison, E. R. Stott, County Councillor G. Turton. Apologies for Absence received from Couns. Mrs. F. M. Roberts & H. D. Craig. In the absence of Coun. Craig, the meeting was conducted by the Vice Chairman, Coun. Miss J. Foxton.

Coun. Bickers Members observed a short silence to the memory of the late Coun. Bickers.

The Minutes of the Annual Assembly and the Council Meeting held on 16th March, having been circulated and approved, were signed by the Vice Chairman,

Prop. Coun. Murkett, sec. Coun. Loveden.

County Councillor Turton attended the meeting to discuss Coach Parking and the refusal of the planning application, submitted by F. D. Todd & Sons, for development to the rear of 70, The Green.

Coach Parking Referring to the District Council's decision to utilise the small car park at Millgate for coach parking, Coun. Turton stated that the surface of the area is not suitable for heavy vehicles and could only be used for a short time. He also considered that the small car park will be required for long stay parking when disc parking is introduced on the Market Place. The County Council favour the grassed island between the link road and the large car park for coach parking, as recommended by the police; the land which has a hard core base could be converted at a cost of £5,000 - £6,000. Coun. Loveden stated that the noise and fumes from coaches will cause a nuisance for the residents of Gillings Court. Members agreed to notify Hambleton District Council that they will accept the use of the small car park by coaches for a maximum of six months and to make a formal request for the provision of coach parking facilities on the grass island as recommended by the police. Coun. Davison suggested that the possibility of the car park being extended to land to the rear should be explored. It was agreed that this should be left until after the elections in May. It was agreed to request Hambleton District Council to designate a taxi rank on the Market Place to prevent taxis from encroaching onto the coach parking area.

Road to 70, The Green Referring to the County Council's insistance that the road be made up to highway standard, Coun. Murkett suggested that the material used could be setts, of the same type used at Riverside Mews, and that there was a need for a footpath at only one side. This would not be a 'through' road as it ends at Todds. Coun. furton stated that he has urged the Highways Department to be as flexible as possible and had asked for a meeting, on site, of all the parties concerned. The Clerk told the meeting that this has been arranged for 30th April at 11.00 a.m. and the Town Council invited to send a representative. It was agreed that Coun. Loveden represent the Town Council and Coun. Murkett will attend as a District Councillor.

Coun. Loveden enquired whether there is any co-ordination between Mechanical Sweepers the County and District Councils regarding street sweeping with mechanical sweepers and was told that the County Council sweeps the roads and the District Council the footpaths and the Market Place. Coun. Turton was tranked for his attendance.

### Matters Arising from the Minutes Annual Assembly

Advertising Boards A letter from Mr. Woods Stated that during the past weeks, a number of traders have been apprached and requested to either remove or re-position their advertising boards and the response has been generally good. The few which remain, including the 'Barratt' sign, will be attended to in the near future. A letter from the Chief Environmental Health Officer H.D.C. stated that the issue of advertising boards has been referred to the Chief Planner & Technical Officer for his attention.

The letter from the Chief E.H.O. informed the Council that the Sponsored Litter Bins Cleansing Officer is initiating a sponsored litter bin scheme in the District whereby local businesses/organisations are being invited to fund litter bins with advertising plates attached. Depending upon the response of the businesses and organisations (approx 100), the Environmental Health Committee will be asked to endorse such a scheme. Details of the type of bins and prices were enclosed.

Sponsored Litter Bins cont/ It was considered that the cost of the litter bins at £88.50 each + V.A.T. with an additional charge for a sponsorship plaque and for artwork and a stencil is too expensive and it was felt that the costs should be shared by the District Council. It was agreed that Coun. Murkett and Coun. Craig take up the matter with the District Council.

Dropped Kerbs A letter from Mr. Woods stated that included in the schedule of works for the coming financial year are footpath works along Castlegate, which will be carried out in late summer or early autumn. At the same time, the opportunity will be taken to provide any further 'dropped' kerbs around the Market Place. Mr. Woods suggested that a member of the Council meet him to agree on the exact locations for the 'dropped' kerbs and Coun. Murkett agreed to attend this meeting.

Thirsk Industrial Park Coun. Murkett produced figures showing that there are now 9 companies operating on the Industrial Park with a total of 67 jobs and 3 more companies will be located there in 1987.

### Matters Arising from the Council Meeting

Bus Shelter - Market Place who is responsible for Counter Services in the Thirsk area, stated that planning permission for alterations to Thirsk Post Office counter was never progressed owing to lack of funds allocated for improvements. A review of Counter Services is being carried out and the Town Council will be informed as soon as a decision is made concerning improvements at Thirsk. A letter from the Chief Executive H.D.C. stated 'I am writing to give formal notice to your Council of my own Council's intention to terminate its agreement to maintain your bus shelter forthwith'. The letter continued that whilst points raised by the Town Council were communicated to members, it was resolved to adhere to their earlier decision with regard to the future of the premises. It was noted that the remaining class has been removed and the structure painted. It was agreed to investigate the possibility of replacing or altering the present structure. Coun. Murkett agreed to ask a local architect if he will provide a plan for altering the bus shelter.

Disc Parking A letter from the Chief Executive H.D.C. stated that paragraph 21(c) of the Order is intended to catch the individual, or individuals, who use the parking spaces for picnics, to excess, and to the detriment of other users of that car park. It would be impossible to define with any accuracy any excessive user, which is why a general prohibition is imposed, with the car park superintendent using his discretion should it be considered that that particular clause warrants enforcement. The letter also stated that the reason for the slight increase in the gross weight of vehicles that are permitted access to the Market Place was upon a recommendation from the North Yorkshire County Council and the police.

Members had received complaints regarding the bollards, erected on the Market Place to prevent vehicles being driven over the Public Service Vehicle area. Chains have been hung between the bollards and it was felt that members of the public, crossing that area, during the hours of darkness, which is not well lit, could fall over the chains. The Clerk was instructed to telephone H.D.C. regarding this and suggesting the removal of the chains and the siting of extra bollards.

Conservation Area Enhancement Scheme - The Holmes Nothing reported.

Heavy Goods Vehicles through Thirsk Nothing reported.

St. Mary's Walk Coun. Roberts has now met Mr. Woods.

Encroachment at Stockton Road

Letter from the Chief Planner & Technical Officer referring to previous correspondence and stating that with reference to the request for street lighting, a copy of the letter has been forwarded to North Yorkshire County Council's Highways Dept. Road Lighting Unit for their attention.

A letter from the Chief Reporter of North Yorkshire News referred to the fact that the Press were asked not to report on the above item at the March meeting and enclosing a copy of the public's rights contained in the Local Government (Access to Information) Act 1985. The Clerk told the meeting that she had spoken to the Chief Reporter about the contents of his letter.

Christmas Lights
The sub committee had met with Mr. Johnston and had been shown a
lantern decoration. The meeting had been attended by the Chairman

Christmas Lights cont/ of the Chamber of Trade who had been asked to request his members to consider participating in the scheme. The sub committee had drawn up a letter, inviting every business in the town to participate and including the prices of the decorations available. A letter from the Chairman of the Chamber of Trade to this Council meeting stated that a sub committee of the Chamber had considered the suggestions and have decided that the £300 over the 3 year period should be adhered to; the Chamber of Trade are 100% behind the Town Council's idea of approaching every business, association and group in the area to æsist in raising the money considered necessary.

Seats Coun. Davison has taken the vandalised R.A.O.B. seat for repair to the Manpower Services Centre at Billingham.

Lights - Public Rights of Way Nothing reported.

Footpaths and Roads
The survey on the footpaths, roads and yards in the Parish, carried out by the late Coun. Bickers, was read to the meeting. It was agreed to keep it with the Council records and to forward a copy to the Museum.

White Mare Roundabout

A letter from Coun. Roberts stated that she had spoken to

Mr. Cartman (Nurseryman) about low growing conifers to plant on
the roundabout. There are 2 sizes available - large ones which are 3' across at a cost
of £12 - £14 each and small ones at £2 - £3 each. He had offered to inspect the roundabout and estimate how many trees would be needed and can supply a variety of colours,
and would deliver direct to the site. It was agreed to plant only a few conifers
initially in case there are problems with the soil, and to leave the planting to
Coun. Foxton and Coun. Roberts.

Town Clock In view of the fact that the cost of the repair and refurbishment of the fabric of the clock can be borrowed from H.D.C. interest free and repayable over the next two financial years, it was agreed that the work should be carried out. Prop. Coun. Murkett, sec. Loveden 'to accept the quotation submitted by F. Marshall of Ripon and request him to carry out the work in the near future.' Agreed.

Local Bus Services A letter from the County Surveyor stated that certain changes have been agreed upon for the Thirsk to Northallerton Service. An additional journey on Monday to Saturday will depart from Thirsk to the Hambleton Estate at 0841 and return to the Market Place to enable passengers to travel on the 0905 departure to Northallerton. The 1200 Northallerton to Thirsk journey will be extended to serve the Hambleton Estate. Additional journeys on Monday to Friday are to be provided on service 155 departing Thirsk at 1400 with a return journey departing from Northallerton at 1555. It has not been possible to provide a service to serve Norby Estate, there being no suitable turning facility for a public service vehicle within the estate and insufficient time within the current schedule requirement to obtain an acceptable diversion to make a turnround possible.

Coun. Loveden stated that he understands that since de-regulation, bus companies are able to make changes at short notice and without notifying the local Councils. It was agreed to ask that the Town Council be notified by the County Council of any proposed changes that would affect Thirsk as soon as they have the information to hand.

Public Conveniences It was reported that the Market Place public conveniences are in the process of renovation.

Cemetery Superintendent The meeting was told that the sub committee had interviewed four applicants for the post of Cemetery Superintendent and have appointed Mr. Jonathan D. Barr. Mr. Hatch is to be consulted on the drawing up of an Agreement with Mr. Barr as a self employed contractor.

Cemetery Lodge Couns. Foxton, Murkett and Loveden, together with the Clerk, had carried out an inspection of Cemetery Lodge to decide upon the location of the Burial Board office. Mr. Collinson had pointed out the state of the window frames and dampness on the walls of the kitchen extension. A damp course had been included in the specifications for the alterations to the kitchen when the Lodge was altered in 1974 but it was evident that it had not been included in the work carried out. It was agreed that work would have to be carried out to cure the dampness as a matter of urgency and that prices would be sought for replacement windows which may have to be done over a longer period of time.

Grass Cutting

Letter received from Mr. M. T. Shipton, who had submitted an unsaccessful tender, pointing out that during the last grass cutting season he had denoted the council of the

Grass Cutting cont/ be sent appreciating his work but stating that it could not be taken into account when considering tenders. When public money is being spent, the lowest tender must be accepted unless there is good reason for it not to be.

Cemetery Grass Cutter

It was agreed that a grass cutter be hired from Power Point at a cost of £11.00 per week + V.A.T. It was also agreed to ask

Power Point and Thirsk Power Tools if they would be interested in purchasing the existing grass cutters at the Cemetery.

Junction - Stammergate/Long Street

A letter from the County Surveyor stated that the requirements for signing a junction where two different speed limits exist are that there should be, in the case of Long Street and Stammergate, a 40mph repeater sign in Long Street on both sides of the junction. The two repeater signs should be within 100 metres of Stammergate. The present position is that there are repeater signs in Long Street within the required distance, and so there is no requirement for any 40 mph sign in Stammergate.

Long Street

A letter from Chief Inspector Whittaker, regarding the problems caused by vehicles as the fish and chip shop, stated that observations have been kept by patrolling officers throughout February and although at times it has to be accepted that the area is busy, there have been no specific offences committed by drivers using these premises. As well as looking at these premises, attention was given to other similar establishments in Thirsk and there would appear to be a greater traffic problem in Westgate than Long Street. Officers will continue to pay attention to all areas of activity which generate a road safety hazard including the premises mentioned and the new Chinese Take-Away in Long Street when it is opened.

Thirsk Local Plan - Draft Written Statement Most members had attended the exhibition in the Town Hall and some had attended the

Public Meeting to discuss the Thirsk Local Plan.

The following observations were made to be forwarded to the Chief Planner H.D.C.:

Industry A split of the Bamlett site into smaller industrial units should be encouraged.

Because of the high unemployment rate in Thirsk, James Herriot's name should be used to encourage tourism and create jobs. Thirsk should be promoted as the town where James Herriot's veterinary practice is located.

Environment Thirsk should be given all the backing necessary for it to be the subject of a 'Town Scheme'.

#### Correspondence

Applications for Listed Building Consent to Demolish Nos. 22 & 24, Finkle Street, Thirsk

Notifications recieved that applications to demolish Woolybacks, 22, Finkle Street and Halifax Building Society Office, 24, Finkle Street are going to be decided by the Secretary of State for the Environment after having a public local enquiry. The enquiry is to be held at 10.00 a.m. on 2nd June at The Golden Fleece Hotel and attendance is invited or alternatively representations can be sent to the Chief Executive H.D.C. before 27th April or direct to the Department of the Environment. It was agreed not to make a decision regarding representations until the new Council meets in May.

Play Equipment - The Holmes

A report from Wicksteed Leisure stated that the surface under the swings is in poor condition and the grass round about requires removing. A new seat is required for one of the swings. It was agreed to order 1 Flat Swing Seat at a cost of £12.00 + V.A.T. & Carriage.

North Yorkshire Playing Fields Association

A letter from the N.Y.P.F.A. gave a reminder that the subscription is now due and it has been necessary to raise the minimum subscription rate to £10.00. It was agreed to pay the increased subscription.

Tape Recorders at Council Meetings

Letter presented from Coun. Murkett regarding the use of tape recorders by the Press at Council meetings which could be used without Council knowledge. Prop. Coun. Murkett, sec. Coun. Loveden 'that the use of tape recorders at Council meetings is not allowed unless permission is sought in writing, and granted.' Agreed.

Footpath - Hambleton Estate

A letter from Coun. Roberts referred to a hedge overhanging
a footpath. As the exact location was not indicated it
was not possible to request Hambleton District Council to take any action.

Bridge Garage A letter from Coun. Roberts stated that she has received complaints about the state of the river bank to the rear of the new building at Bridge Garage where builders have deposited rubole, and which is an eyesore when viewed from Finkle Street Bridge and the Library. It was agreed to draw this to the attention of the Cod Beck Internal Drainage Board and also to mention the state of the bank on the opposite side of the river at the rear of the coal depot. Coun. Roberts also stated that there are complaints about the footpath from Ingramgate to Duckett Ings which is churned up due to the driving of vehicles over it. This to be drawn to the attention of the Footpaths Officer N.Y.C.C.

#### Matters Arising from the Minutes

Coach Parking

A letter from the Chief Executive H.D.C. stated that the Town Council's request for the grassed island between the link road and the car park to be designated for coach parking will be considered by the Leisure and Amenities

Taxi Rank A copy of a letter from the Chief Executive H.D.C. to all the hackney carriage firms in the area, was read to the meeting. The letter stated that when the Thirsk (Off Street Parking Places) Order was advertised, there had been no requests for the provision of an area specifically for use by hackney carriages. Attention has now been drawn to the fact that the area of the Market Place set aside for use by scheduled Public Service Vehicles is being used from time to time by hackney carriages plying for hire. The use of that area contravenes the Order and could lead to the person using the vehicle being liable for a fine of up to a maximum of £100. Should a hackney carriage stand now be requested, it could only be provided by the making of a Byelaw and if part of the Market Place is to be set aside for that purpose, the Thirsk (Off Street Parking Places) Order will need to be amended. If a stand is provided, it could not be in any area specifically set aside for scheduled bus services picking up or setting down passengers. Members agreed that there should be a stand in order that members of the public are aware of where to find a taxi. It was agreed to request H.D.C. to provide a taxi stand and to suggest that the area in front of Rukins and House of Troy as a suitable

Advertising Boards Nothing reported.

Sponsored Litter Bins The relevant H.D.C. Committee has not yet held a meeting.

Bus Shelter Coun. Murkett stated that a plan is being drawn.

Members agreed that the Disc Parking scheme is receiving more praise than criticism. It was also agreed that more parking space is needed at Millgate Car Park. Hambleton District Council to be told that steps should be taken now to extend the Car Park regardless of the fact that there may be parking spaces available if planning permission is given for a supermarket at The Nurseries. Coun. Murkett had received complaints that disabled drivers, who also use wheelchairs, experience difficulties when parking on the allotted sites to the east of the Town Clock, as there is insufficient space for the unloading of wheelchairs. It was agreed to request that two of the spaces for car parking, parallel to the pavement, at the front of Fine Fare be allocated for disabled parking. This would allow for the unloading of wheelchairs directly onto the pavement.

Conservation Area Enhancement Scheme - The Holmes It was reported that the owner of the land to the rear of Millgate Car Park had agreed to allow a footpath through his land and H.D.C. were also agreeable to their land being included. The Chairman agreed to contact the Richmond Conservation Volunteers regarding the making up of the footpath. Coun. Murkett stated that the Rotary Club wished to be involved in the scheme. The Chairman to arrange a meeting of interested parties.

Heavy Goods Vehicles Through Thirsk

It was reported that a traffic census was being carried out in the Market Place this day.

St. Mary's Walk Coun. Roberts stated that she and Mr. Woods had surveyed the area and is now awaiting the outcome of the enquiries regarding ownership that he intended to make. It was agreed to make application for this section of path, which is an unofficial link from St. Mary's to the Barratt Estate, to be designated as a public footpath.

Christmas Lights The meeting was told that all businesses with premises fronting onto the Market Place and side streets had been circulated regarding the proposed Christmas Decorations and so far there had been a fair response. The closing date for replies was the last day of May. It was agreed that the Sub Committee meet with Mr. Johnston, the electrician, on 4th June.

Seats A quotation for repairs to the R.A.O.B. seat had been received from the Employment Service Agency Rehabilitation Centre, Billingham at a cost of £35.00 - being the cost of materials plus 25%. A claim had been made to the Insurance Company for this amount plus the cost of delivery to Billingham and return.

Lights - Public Rights of Way Nothing reported.

White Mare Roundabout Coun. Roberts stated that two conifers have been donated for planting on the roundabout and with the promised grant of £50 from the N.Y.C.C. the cost to the Town Council this year should not be very high.

Town Clock A letter from the Yorkshire L.C.A. stated that they are unable to find any clearly defined source of funding for repairs to the clock, other than the District and County Councils although it may be possible to obtain a grant from the local tourist board. A letter from the Chief Planner H.D.C. stated that the Planning Committee have resolved to offer a grant of £500 from the Council's Urban Conservation Fund and payment will only be made on completion of the work to the satisfaction of the Chief Planner & Technical Officer. Members who had met with the stonemason had been told that additional work is required at the top of the clock tower and a price will be submitted. The members who had been present had agreed that if the work is essential it will have to be carried out. A letter from Mr. Stott referred to the vandalism that had been perpertrated on the clock face by vandals scaling the scaffolding and suggested that Messrs. Potts be asked to remove the external pointers until the repairs are completed. It was agreed to ask Messrs. Potts to do this and to give a quotation for making good the damage. At the suggestion of Coun. Murkett, it was agreed to write to the Queen inviting her to make a donation to the cost of repairs to the clock which was erected by public subscription to celebrate the wedding of her grandparents.

Local Bus Services A letter from the County Surveyor's Department stated that it would not be practicable to consult Town/Parish Councils on individual changes to local bus services but it has been agreed that Annual Liason Meetings will be held with Town/Parish Councils on an Area/District basis to discuss Public Transport matters, and when dates have been agreed Thirsk Town Council will be invited to attend.

Apologies for Absence received from Coun. D. S. Murkett.

Minutes The Minutes of the previous meeting, having been circulated and approved were signed by the Chairman. Prop. Coun. Craig, sec. Coun. Loveden.

Chairman Before continuing with the meeting, the Chairman thanked Coun. Craig for the work he carried out during his year in the 'Chair' and for his help to her when she was Vice Chairman.

The Chairman referred to the unusual length of the previous meeting, stating that it had been due partly to an inexperienced Chairman, a lengthy Agenda, explaining matters to new Councillors and the somewhat unruly behaviour of some members. The Chairman requested members to address all matters to the 'Chair' and not to deviate from the subjects under discussion.

### Matters Arising from the Minutes

Coach Parking Nothing reported.

Taxi Rank and Parking for the Disabled A letter from the Chief Executive H.D.C. stated that for any part of the Market Place covered by the Thirsk (Off Street Parking Places) Crder 1987 to be utilised for a Hackney Carriage stand or for parking exclusively by the disabled, it would necessitate a modification of the existing Order of which the procedural requirements of the relevant Regulations dictate that at least 3 Committees must elapse before any such amendment can finally be made. The Hambleton District Council is looking into the possibility of providing the Swimming Baths car park as an Off Street car park and for the disc parking scheme to be extended to that area. Where it is feasible, it would seem sensible, rather than incur increased expenditure on repeated amendments of the existing Order, for all such amendments or modifications to be made if the disc parking scheme is to be extended to the Swimming Baths car park.

The Chief Executive also stated that he will be interested in the Town Council's views, consequent to being advised of discussions with certain Hackney Carriage operators. None of the 4 firms licensed to run Hackney Carriages within the Thirsk area, have responded to a letter by indicating that they wished for a Hackney Carriage stand to be provided. Bencabs and Reynard Taxis have indicated that they do not wish to operate from a stand and have intimated that once the current licences expire they may then consider the relevance of renewing the licences as most of their trade comes via the telephone. When the licences expire in January 1988 and they decide they do not wish them to be renewed, it could be that a Hackney Carriage stand has been provided without Hackney Carriages. It would then prompt a further amendment to the Off Street Car Parking Order to enable the stand to be used for Disc Parking. Members agreed that as there had been no response to the District Council, it was obvious that a taxi rank is not required at the present time, but that vehicles for hire, without Hackney Carriage licences, should not be allowed to ply for trade on the Market Place.

Coun. Roberts stated that the doctors at the Pick's Lane surgery had enquired if the

Coun. Roberts stated that the doctors at the Pick's Lane surgery had enquired if the disc parking scheme could be extended to Pick's Lane for the convenience of their patients who are unable to park due to long stay parking by other motorists. It was agreed that members would survey the area and discuss at the next meeting whether to make application for restricted parking on that Koad.

Advertising Boards & Sponsored Litter Bins A letter from the Chief Planner stated that he shares the Town Council's concern at the proliferation of advertising boards in the Market Place but does not think that the display of advertisements on litter bins would offer a solution. The proposal would entail the introduction of further street furniture into an already cluttered area and is one he could not support. One possible solution would be the establishment of an Area of Special Control of Advertisements whereby a higher degree of control of advertisements could be achieved. The Thirsk Local Plan Draft Written Statement proposes that consideration be given to this is Policy E.16.

Bus Shelter Due to the absence of Coun. Murkett nothing was reported on this matter.

Conservation Area Enhancement Scheme - The Holmes The Chairman is to contact the Richmond Conservation Volunteers.

St. Mary's Walk - Footpath Mr. Fawcett, N.Y.C.C. Footpaths Officer, had told Coun.

Roberts that the Town Council can make application for the path to be designated as a Public Footpath. Mr. Fawcett had also told the Clerk that a review of Public Footpaths is to take place in the near future and the Council can make application at that time.

Christmas Lights The Sub Committee had met to discuss the replies received from business people in the town and had been disappointed at the response.

Messrs. Woodhead & Lowe, Chemists, had agreed to a decoration being erected on their shop for inspection and the Chairman and Coun. Bentley are to personally approach all business people who have not replied to the letter which had been circulated. A report will be given at the next meeting.

Cod Beck Drainage Rates A letter from the Treasurer H.D.C. stated that the problem of the payment of drainage rates by the District Council has been raised several times since reorganisation and on each occasion the Council has declined to do so. Although in the case of Thirsk, the cost appears quite trivial, in the District as a whole, with many Internal Drainage Districts, the charges become quite substantial. In 1974, on reorganisation and merger of the various Councils, only Easingwold District Council paid individual drainage rates and charged the cost against the General Rate. In the other areas, including Thirsk, this power was not taken up and the new Hambleton District agreed that they would similarly not do so. There does not seem to be any likelihood that the policy adopted in 1974 and confirmed on several occasions since that date, is likely to be changed.

It was agreed to write to the Yorkshire Local Councils Association requesting that the subject of Drainage Rates be placed on the Agendas of the Hambleton South and North Branch meetings.

Home Defence Coun. Bentley stated that he has not yet organised a meeting of interested parties. The Home Defence Emergency Committee will pay the cost of hiring a meeting room.

Pumping Station - P.L.C. Homes

A letter from P.L.C. Homes stated that the pumps at the Shire Park Estate were manufactured and supplied by and are maintained by Flygt Pumps Ltd of Colwick, Nottingham. It was agreed to write to Flygt Pumps and to the Principal Technical Officer H.D.C. regarding the problems with the pumping station and asking for their comments and suggestions as to how they can be overcome.

Parking - Post Office Sorting Office

Christmas Lights Coun. Bently reported that he and the Chairman had visited 25% of the business premises in and around the Market Place and had met with a certain amount of apathy towards the scheme. Some traders intend to put up their own lights and decorations and it is hoped to liase with them. The remainder of the premises will be visited before the Sub Committee meeting which was arranged for 6th August. It was agreed to invite representatives of Rotary, Round Table and the Chamber of Trade to attend the meeting.

Mill Gardens It was agreed that Mill Gardens are in need of attention. Coun. Roberts recommended the winter planting of shrubs which would have more chance of becoming established when the gardens are not being used by the public. Coun. Tate suggested that a local organisation be asked to take over the maintenance of Mill Gardens. Coun. Murkett stated that he will suggest to the H.D.C. Leisure in Hambleton South & Proposed New Swimming Pool at Northallerton the Chief

Executive H.D.C. stated that his Council is absolutely satisfied that there is no real alternative other than to provide a new swimming pool of some sort in Northallerton. The existing pool is not owned by the District Council but is managed by them and the land on which it is erected is owned by Northallerton Town Council in a charitable trust capacity. It is not practicable to either replace the existing pool at or around the same site within a reasonable time span nor to produce an acceptable form of preservation for the building which is currently in Northallerton. The Stone Cross site was originally intended for recreational use and when the decision was taken to build the new Civic Headquarters it was decided that the remainder of the site should be used for recreational purposes. Car parking has already been provided on the site which is believed to be ideal for a facility intended to serve Hambleton as a whole, not merely Northallerton. Leisure pools such as the one proposed, regularly have a catchment area of up to forty miles and the facilities will be such as to attract users from all parts of the District. It is hoped to attract people from further afield and provide and cont.

Proposed New Swimming Pool cont/ indoor tourist facility for which it is hoped to obtain capital grant from the Tourist Board as well as the Sports Council. The leisure pool is to take priority on the list of recreational schemes of District significance, the next item being a sports hall at Easingwold which it is hoped to start in three years time. The Council recognises the concern about the pool in certain parts of the District. There is no real choice in Northallerton. Either the existing pool in its deteriorating state is retained or a new one is built. The only choice is whether the new pool should be a leisurised or traditional pool and for a difference in cost of less than £2M the Council believes that the general revenue and likely number of users fully justifies the leisurised facility.

It was agreed to request details from the District Council of the projected financial involvement and to write to all members of Hambleton District Council stating the opinion of Thirsk Town Council on the proposed new swimming pool at Northallerton.

Cod Beck Drainage Rates

vehicles by other vehicles parking in front of the office entrance.

Bollards and Chains - Market Place A letter from the Principal Technical Officer stated that the Council will continue to use the bollards and chains and provide better fixing arrangements for the chains to the posts so that they cannot be removed so easily. The situation will be monitored and reassessed at a later date. Members were concerned that the chains had caused accidents to pedestrians and a cyclist. It was agreed to seek the advice of H.M. Factory Inspectorate or the Health and Safety Executive regarding the use of chains in this manner.

Mill Gardens In the absence of Coun. Murkett, it was not known if he had obtained advice on Mill Gardens.

Planning Application - A. B. Rose A letter from the Chief Environmental Health Officer stated that a dispute arose between A. B. Rose & Co. and the District Council regarding the height of the chimney and an appeal was lodged and determined in favour of the Council's proposals that the chimney height should be increased to 14 metres ro comply with the provisions of the Clean Air Acts. The height has been calculated as being the minimum required to dissipate the products of combustion so as to minimise any nuisance potential that the chimney may have. A copy of a letter to the Chief Executive H.D.C. from Mr. Peter Tyas, objecting to the proposed increase in the chimney's height, was read to the meeting.

## Objectives for the Town Council for the next 12 Months

The following Objectives were put forward for consideration, in addition to those submitted by Coun. Tate at the last meeting:

Coun Pantley. Me draw up a Local Chide for Thirek and Sowerhy.

Objectives cont/ Coun. Bentley told members that the type of Guide that he envisaged would list businesses, facilities, local organisations etc. and be issued to every household in Thirsk and Sowerby. It was pointed out that both the Community Care Association and the Museum publish guides.

Coun. Loveden: To Take Action regarding the Litter and Filthy State of Thirsk.

Coun. Loveden stated that he is disgusted with the state of Thirsk and suggested meeting with the supervisor of street sweeping to point out the problems.

Coun. Roberts: To Persuade the District and County Councils to spend money in places other then Northallerton. Coun. Roberts stated that Thirsk is part of the Hambleton District and that money should be spent improving the town instead of the large amounts being lavished on Northallerton.

Coun. Foxton: To Promote Thirsk Town Council. Coun. Foxton stated that Councillors should make themselves known to the ratepayers and listen to their problems. She suggested that Councillors hold 'surgeries' for this purpose. It was suggested that the East Thirsk Community Association caravan and the Town Hall could be used for this purpose.

It was agreed to accept Coun. Bentley's objective inasmuch as he was empowered to liase with the Community Care Association and other organisations in the drawing up of their guides and the Town Council would give support.

The <u>objectives</u> put forward by <u>Coun. Loveden and Coun. Foxton</u> were also accepted. <u>Coun. Tate</u> agreed that his <u>objective</u> regarding the involvement of more people in <u>Town</u> Council affairs could be incorporated with that of Coun. Foxton.

Christmas Lights

Goun. Bentley reported that an order for 56 half decorations has been placed with the manufacturer, consisting of 41 actual orders + one half decoration for each monetary donation + 3 extras. The Chairman stated that the decorations are to be painted by members of the Castlegate Youth Centre. Coun. Bentley also reported that more money is needed for lights to supplement decorations. There are still business premises in the town to be approached so more donations may be forthcoming. A sub committee meeting was arranged in order to draw up a letter to send to business persons who have not participated in the scheme.

Additional Finance for Christmas Lights

At the previous sub committee meeting, ways of raising extra revenue for the Christmas Lights had been discussed. Coun. Roberts had suggested holding a Car Boot Sale on the Swimming Baths Car Park. A letter had been sent to Hambleton District Council regarding the use of the Car Park for this purpose. A reply from the Deputy Clerk of the Council stated that the proposal had been discussed with the Baths Superintendent who is also Secretary of Thirsk and Sowerby Flatts Preservation Trust, the owners of the Car Park. The Superintendent, Mr. Currie, had stated that as far as he is aware the Flatts Trust is unlikely to object. As far as the District Council is concerned, no problems are envisaged but enquiries are being made and if necessary the matter can be discussed at the Baths Management Committee on 3rd September. In the meantime it is suggested that the Town Council liaise direct with Mr. Currie. The Clerk was instructed to contact Mr. Currie and the suggested date for the Car Boot Sale was 27th September. Coun. Moberts to obtain information regarding advertising, charging etc.

Grass Cutting Members agreed that this season's grass cutting is not up to the standard of last year's. Coun. Bentley suggested that this Council adopt the District Council's method of tendering. Hambleton District Council to be asked for a copy of their tendering document.

#### Correspondence

Appeal Notification received that an Appeal by White Horse Office Systems Ltd against Hambleton District Council's refusal to grant planning permission for the display of two internally illuminated projecting signs, has been dismissed.

Football Trust Grants Details received of Football Trust Grants that are available to Local Authorities.

Public Lighting - Newsham Road Letter presented from the Secretary of Thirsk Athletic Club regarding the necessity for street lighting on Newsham Road for the safety and convenience of members of the Club during the winter months. It was agreed to request Hambleton District Council to provide lighting on that stretch of Newsham Road and to invite the support of the Ambulance and Fire Services, whose stations are in the near vicinity.

Apologies for Absence received from Coun. Mrs. F. M. Roberts.

The Minutes of the previous meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Loveden, sec. Coun. Hall.

### Matters Arising from the Minutes

Bus Shelter Coun. Murkett stated that the architect needed details of the type of bus shelter envisaged before drawing up a plan. It was agreed that it should be of brick with a pitched roof, built-in seats, perspex end windows and a two thirds open front facing the Market Place.

Town Clock

A letter from Municipal Mutual Insurance stated that the Insurance Policy covers the theft and damage to the clock hands subject to the £25.00 excess applicable. The Policy does not cover the cost of removing the hands to prevent further vandalism. It was agreed to reply stating that if the other hands had not been removed, they would also have been subject to vandalism and a claim far in excess of the account from William Potts & Sons would have been made.

Public Footpath Survey Nothing reported.

Zebra Crossing - Long Street
The Chairman reported on the meeting with Mr. Appleton of the County Surveyor's Department where it had been agreed that the Zebra Crossing will be moved to a site north of Piper Lane.

Parking - Pick's Lane Nothing reported.

Swimming/Leisure Pool at Northallerton Letters presented from the Chief Executive H.D.C. stating that he had seen a copy of the letter circulated to all Members of the District Council and assuring the Town Council that their general concern is known and appreciated but before the decision to proceed with the project was made, very extensive exercises were carried out by the District Council involving inspection of new swimming pools in various parts of the country and two days of presentations from almost every firm of specialists in this field. There was also very extensive debate, both at Committee and Council level. A report of the Chief Executive, Treasurer and Chief Planner & Technical Officer, which had been submitted to the Policy and Resources and Leisure and Amenities Committees was also received. Coun. Murkett reported that when the proposal for the new pool was put to the District Council, it was carried by 30 votes to 4. All the Parish Council members of the L.C.A. Hambleton South branch unanimously objected to the proposed pool but they did not receive the support of their District Council representatives. Letters were received from two members of the District Council, in reply to this Council's letter, disagreeing with the Town Council's views.

Home Defence Coun. Bentley stated that he hopes to hold a meeting in the near future.

Pumping Station - Shire Park

Letter received from the Chief Planner & Technical Officer stating that P.L.C. Homes have recently requested the District Council to adopt the foul and surface water drainage system which serves the site and have also submitted a video film of the existing conditions. The comments received from the Town Council will be taken into account when the proposed agreement is placed before the Council. Coun. Murkett requested that the District Council's attention be drawn to the fact that on several occasions recently, foul sewage has been in the river near the pumping station at Finkle Street Bridge.

Bollards and Chains - Market Place A letter from the Chief Planner & Technical Officer stated that the matter is being looked into and a report will be submitted to the hext Leisure & Amenities Committee meeting. Members referred to the fact that Coun. Tate had removed the chains. Coun. Murkett regretted that a member of the Town Council had taken matters into his own hands and felt that the District Council will dig in their heels and replace the chains. The Chairman pointed out that Coun. Tate had acted as an individual and not as a representative of the Town Council. Coun. Craig stated that such action left the door open for any individual to take the law into their own hands. Coun. Tate stated that he had received support from members of the public and did not reget his actions.

Mill Gardens Coun. Murkett stated that he hopes an inspection will be carried out in the near future.

#### Objectives

Promoting the Town Council

The Chairman stated that the meeting at Stone Cross had been 'promoting' the Town Council and that the first 'surgery' will be at the Car Boot Sale when Councillors will be present to meet members of the public.

Litter It was agreed to request a copy of the schedule for the Town Sweeper and to request a site meeting with the Officer responsible for Street Sweeping.

Christmas Lights Coun. Bentley reported that a draft letter is being finalised to be sent out thanking participants for their sponsorship, requesting the promised payment and reminding non-participants that money is still required for extrastrings of lights to complete the illumination of the town. A request had been made to the District Council for the replacement of the socket and rings on the cobbles outside the Golden Fleece in order that a Christmas Tree can be erected. A reply is awaited.

Public Lighting - Newsham Road

A letter from the Chief Planner stated that a scheme for the provision of a system of lighting in Newsham Road has been included in the Footway Lighting Capital Programme for implementation during the 1989/90 financial year. It was agreed to request that the scheme be brought forward in view of the large number of young people using the road to visit the Athletic Club in winter.

Grass Cutting A copy of the District Council's tendering specification received.

Thirsk 'Promotional' Sign A letter from the Chief Planner stated that tourism signs, designed to advise motorists of the services available in by-passed towns, have been re-designed in the new white on brown colour scheme which will apply to all official highway tourist-related signposting. The replacement of the two signs on the A168 will cost in the order of £2,000 and it is hoped that this will be carried out in the next financial year in time for the tourist season. There are three elements to the signs, as shown on an enclosed example. 1. Place name. 2. Brief description (not more than three words). 3. Local services followed by the standard symbols for those facilities available in the town. The Town Council are invited to give consideration to the three-word description that they would like to see on the sign. It is hoped to have the content of the sign approved by the Department of Transport in time to submit an order to the manufactureres towards the end of the current financial year. It was unanimously agreed that the three-word description should be 'JAMES HERRIOT'S TOWN'. Mr. Wight to be notified of this.

Shire Park
A letter from the Chief Planner stated that the site has been inspected by
the Enforcement Officer and the developers of the estate have been requested
to supply details of their intentions regarding this area. They have been advised that
the Planning Permission contained an agreement requiring them to create and maintain a
play space on the estate.

A letter from the Chief Planner stated that an inspection of the site by the Enforcement Officer found that the archway of the boundary wall exceeded 2m in height and therefore required planning permission. The owner of the property has been given the necessary forms on which to apply for planning permission. He intends replacing the hedge with a similar type of hedging.

Technical Officer Mr. Adams, and the Chairman of the Leisure & Amenities Committee Coun. Weighell, was attended by Couns. Foxton, Loveden, Hall, Tate, Davison, Murkett and Craig and the Clerk. A Planning Officer Miss Ashley was also present. Mr. Spencer told the meeting that the Estimates for the next financial year will include £25,000 for coach parking on a unspecified site in Thirsk, and if approved, the work should be completed in time for the 1988 tourist season. The District Council preferred site, for a coach parking lay-by, at the Kirkgate end of the Millgate Car Park could involve the need to acquire a small area of land from Thirsk Hall Estate. Coun. Hall put forward the Chamber of Trade's view that the sites for which they had applied for planning permission would be less costly that the District Council's scheme but was told by the Planning Officer that the County Surveyor had recommended refusal of planning permission.

Meeting at Stone Cross cont/ Members had requested that a long term view be taken of car parking in Thirsk and that part of the grassed area of Millgate Car Park be removed to provide additional parking spaces.

A discussion had taken place on the proposed new swimming/leisure pool at Northallerton and the same replies received as in correspondence on the subject.

At this Council's meeting, Coun. Hall expressed concern that if the District Council is unable to procure any additional land from the Thirsk Hall Estate that may be required to provide a coach parking lay-by on the preferred site and the Planning Committee accept the County Surveyor's recommendation to refuse the Chamber of Trade's planning application. Thirsk will still be without coach parking facilities. It was agreed to write to the Chief Executive pointing this out and requesting that all options be kept open and all possible areas pursued to ensure that Thirsk will get its much needed coach parking area in early 1988.

Clerk. The Cemetery Fees had been discussed and it had been agreed that they should be increased. A further meeting will be held and the recommendations put before the Council. Complaints had been received that the grass cutting was not up to standard but the Superintendent had been working under difficult conditions. It was agreed that regular sub committee meetings will be held and any complaints passed to the Superintendent. The strimmer had been sent in for repair. Following complaints, it had been agreed that a tree near the wall separating the Cemetery from the allotments should be removed.

Bungalows at Dowber Way Coun. Tate stated that he had heard that building might be going to take place at the area where the ditch had been culverted and he felt that the area should be used for recreation. Coun. Craig stated that there had been no planning application for this area but he was of the opinion that it could be built on. It was pointed out that the area is designated for landscaping in the Thirsk District Plan.

### Correspondence

Access for the Disabled A letter from the Chief Planner drew attention to the recent designation of the Senior Assistant Building Control Officer, Mr. David Bunch, as Acc ess Officer for the Council, whose main role is to act as a link between the disabled community and those able to influence their environment and to try to represent their interests in a wide range of activities. These activities include housing (public and private), public buildings and facilities, highway improvements and car parking, commercial developments, shops, offices and factories.

Hambleton Visitor Guide

A letter from the Chief Planner expressed disappointment that
Thirsk Town Council does not intend to take an advertisement
in the 1988 Guide as Thirsk is probably the most popular destination for visitors to
the District. Bedale, Northallerton and Great Ayton are all using the Guide to promote
their towns and offer a welcome to visitors. It is hoped that the Town Council may wish
to reconsider the decision and join in the promotion of tourism which can bring income
and employment to the town. It was agreed to adhere to the original decison not to
advertise in the Hambleton Visitor Guide.

Publicity for participants in the Christmas Lights scheme to appear in the December issue of the Thirsk Advertiser.

A letter from the Chief Planner & Technical Officer stated that although the Leisure and Amenities Committee appreciate the urgent need for lighting in Newsham Road, two other schemes were considered to have greater priority and it was decided that the Newsham Road sheme should be included within the 1989/90 programme. Coun. Craig agreed to press for earlier implementation of the scheme. It was decided to request an extension of the 30 m.p.h. speed limit on Newsham Road to the junction with Cemetery Road, pointing out the lack of a footpath and

the number of pedestrians visiting the Athletic Club.  $\triangle \triangle V$ 

Cemetery It was reported that work on the Burial Board Office has not yet been completed. A Sub Committee was arranged to take place in the Office on 3rd November. Mr. Barr to be told that the work on the Office must be finished and the Office in use before that date. Complaints had been received from the public that the general state of upkeep of the Cemetery is not up to standard. Coun. Craig had received complaints from funeral 'bearers' about the ropes used to lower coffins. It was agreed to obtain a price for webbing harness. It was agreed to pay the account for the installation and connection of a telephone service to Cemetery Lodge along with the rental which was agreed previously. It was decided to purchase a telephone to replace the one currently rented. Coun. Loveden agreed to obtain one.

Report on Meeting re: Street Sweeping Couns. Roberts, Loveden and Davison and the Clerk had met with the Principal Technical Officer and the Cleansing Officer, who has recently taken over responsibility for Street Sweeping, together with his assistant. It was suggested to the Officers that the Street Sweeping programme be re-appraised, with more time being spent on sweeping the Market Place and less on emptying litter bins. Coun. Loveden requested that there be more supervision and that hours of work and terms of reference be tighter. It had been agreed that the Street Sweeper will be allowed to sweep the snickets from where litter blows onto the Market Place. It was agreed to allow time for the re-organisation to be established and to leave Street Sweeping on the Agenda.

Coach Parking

The H.D.C. Planning Committee had held a site meeting on Millgate Car

Park, to inspect the Chamber of Trade's application site and the District

Council's preferred site. Representatives of the Chamber of Trade and the Town Council

had been invited to attend. It had been stated that Mr. Bell will not reliniquish land

to accommodate the District Council's plan. Coun. Hall reported on a discussion which

had taken place with the Principal Technical Officer after the site meeting, at which a

plan had been produced showing a coach park on the large car park which would involve

the loss of grassed area and would meet all requirements. Members were shown a copy of

the plan and were unanimously in favour. It was agreed to request implementation of

the scheme as a matter of urgency. Concern had been expressed that lorries would park

on the coach area. Coun. Murkett stated that if the area is a designated coach park,

it will come under the jurisdiction of the police.

Joint Meeting to Discuss the Town Hall Annexe Coun. Roberts reported that those present at the meeting had agreed that funds are not available for a new annexe at present. The condition of the annexe is reasonable, new fire doors have been installed. Rewiring is necessary and the exterior requires painting. The cost of these works will be met from funds set aside by the Councils. An account had been received for the new fire doors and roof repairs. Coun. Bentley stated that Sowerby Parish Council is willing to meet half of the cost from its Town Hall allocation if the Town Council will do the same. Prop. Coun. Murkett, sec. Coun. Craig 'to meet half the cost of the account.' Agreed. The Town Council will pay the total account and reclaim half from Sowerby Parish Council.

#### Correspondence

Conservation Area Enhancement Scheme - The Holmes A letter from Coun. Foxton stated that the British Conservation Trust

Volunteers have suggested that rather than lay a formal footpath along the riverside through Calvert's field, a stile be erected at either end to ascertain if the path is used. Coun. Murkett agreed to seek Mr. Calvert's agreement. The Volunteers will also landscape the piece of District Council land at the end of the Car Park and remove dead trees from the river.

70, The Green Letter received from Lester & Hatch, Solicitors, expressing concern at the failure of the District Council to issue an approved Planning Consent for residential development for F. D. Todd & Sons at land to the rear of 70, The Green and maintaining that the road in question is a 'highway'. It was agreed to reply stating that a further planning application is necessary in view of the fact that the previous one was refused.

Minutes The Minutes of the previous meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Loveden, sec. Coun. Craig.

### Matters Arising from the Minutes

Bus Shelter/Post Office A letter from the Persinnel & Services Manager, Post Office - Leeds - stated that the review of Counter Services is continuing and when the network review is completed the Town Council will be notified.

Town Clock

A letter from Municipal Mutual Insurance requested that they be advised of any developments which may affect their interest in the matter of compensation. The Clerk reported that £4.00 has been received from the Clerk to the Justices as part compensation for damage to the clock.

Swimming/Leisure Pool Coun. Craig reported that the District Council has decided to proceed with the project. Coun. Bentley requested that the District Council be asked if there will be the provision of extra transport to Northallerton from within the predicted catchment area in order for members of the public to travel to use the facilities at Stone Cross.

Home Defence The meeting has not yet taken place.

Mill Gardens Coun. Murkett to be asked for a report for the December meeting.

White Mare Roundabout A letter from Mr. Woods referred to weeds which had grown on the roundabout and which have been removed by County Council personnel. The letter also pointed out that the Town Council had agreed to carry out the routine maintenance on the roundabout, which included removing weeds etc., in return for an annual payment of £50.00. If the Council be unable to carry out this work, then the agreement may have to be reviewed or brought to a conclusion. Mr. Woods suggested that members may wish to discuss the matter with him.

Christmas Lights

The Chairman reported on a Sub Committee meeting attended by herself,
Coun. Roberts and Coun. Loveden. The decorations are to be painted
by members of the Castlegate Youth Centre. Mr. Johnston intends to start putting up the
decorations on 1st December and it is hoped to have them illuminated 2/3 weeks before
Christmas. It had been suggested that the Christmas Tree should be a minimum of 20 feet
high. Confirmation of the tree site awaited from the District Council. Coun. Bentley
registered his objection to the suggested tree site after resigning from the Christmas
Lights Sub Committee. Publicity for everyone participating in or contributing towards
the Christmas Decorations Scheme will appear in the December issue of the Thirsk
Advertiser.

Public Lighting/Extended Speed Limit - Newsham Road Reply awaited from County Surveyor.

Street Sweeping Coun. Loveden had been told by Mr. Hayward, the Officer in Charge of Street Sweeping, that all the matters discussed are in hand.

Coach Parking The Clerk reported on a telephone conversation with Mr. Adams, Principal Technical Officer, who had stated that it is the intention to make a coach parking layby on the District Council's preferred site. The boundaries had been agreed with the Thirsk Hall Estate and the area would provide parking for four coaches with the footpath continuing behind the coach parking area. The Town Council's seat, presently located in the centre of the proposed parking area will be relocated. Members referred to a press report which stated that the District Council's scheme would cost £25,000 whereas the scheme involving the large car park would cost £40,000. It was agreed to write to the Chief Executive expressing dismay at the total disregard of the Town Council, Chamber of Trade and Civic Society. It had been understood that the plan submitted following the site meeting had been acceptable to all parties. was agreed to question the cost £40,000 quoted for this scheme. The District Council's preferred site is an area of special landscaping and would not provide sufficient parking spaces - 4 being considered to be inadequate. It was agreed to request that Coach Parking be included on the agenda for the next meeting of the H.D.C. Full Council and that the letter from the Town Council be read to the meeting.

Conservation Area Enhancement Scheme Due to the absence of Coun. Murkett, it was not known if Mr. Calvert's agreement has been obtained.

A letter from the Chief Planner & Technical Officer invited applications and details for schemes for the year 1988/89.

The Green It was reported that the vehicle parked on the grass outside No. 88, The Green has been removed. The Chairman reported on complaints received about an unlicensed car which has been parked outside No. 36, The Green for a considerable time. Two letters of complaint had been received, in addition to telephone calls, and it appeared there was a vendetta against the car owner. The owner had been approached and had assured the Chairman and the Clerk that the car will be removed by the end of the month. It was pointed out that if the byelaws are enforced, all cars will have to be removed from The Greens. It was agreed to consider, at the next meeting, amending or updating the byelaws. The Yorkshire L.C.A. to be asked for advice on this matter.

Footpaths

A letter from the Divisional Surveyor stated that routine repairs will be carried out on areas in need of attention in the near future. Kerbing and resurfacing will be carried out in Castlegate in the new year.

Rights of Way Committee A Committee was formed, consisting of The Chairman, Vice Chairman, Coun. Tate and Coun. Craig.

Seats Members were requested to carry out a survey of the seats in their areas.

Room for Council Use at the Town Hall Coun. Bentley stated that there is a need for a room for Council use at the Town Hall which could be used for storage, surgeries, sub committee meetings, the availability of plans for inspection by the public and for shared office equipment e.g. a photo copier. He considered that we may be able to use the office occupied by the C.A.B. who use it on only two days each week. Coun. Loveden stated that he agreed in principle but could not accept that the C.A.B. office could be used. To the suggestion that the small room behind the Ladies' cloakroom might be suitable, it was pointed out that this is used by both C.A.B. and C.C.A. for storage and interviews. Coun. Roberts and Coun. Davison were of the opinion that an office could be incorporated if a new annexe is built. It was agreed to discuss the matter again at the January 1988 meeting.

Cemetery Sub Committee Meeting

The Chairman reported on the meeting which had been attended by herself, the Vice Chairman, Coun. Loveden and the Clerk. The decoration of the Burial Board Office had been completed and a desk and filing cabinet are needed before the office can be brought into use. The Chairman is hopeful of obtaining a desk at a reasonable price. The Clerk stated that a filing cabinet can be obtained from the Yorkshire Purchasing Organisation at a 60% discount. Permission was given to order one. The increases and amendments to the Cemetery Fees, as recommended by the Sub Committee were presented to the meeting. Prop. Coun. Loveden, sec. Coun. Hall 'that the recommendations of the sub committee be accepted and brought into operation on 1st January 1988.' Agreed. It was agreed that the fees be revised on an annual basis. The Cemetery Superintendent had pointed out that the windows of Cemetery Lodge are in need of replacement and had obtained a quotation for replacement of all the windows with double glazed U.P.V.C. units at a cost of £2,500. It was agreed that further quotations be sought and to consider the replacement of the windows when discussing the Precept.

Zebra Crossing - Long Street It had been necessary to reconsider the proposed re-siting of the Crossing because of the proposed housing development by the District Council the entrance to which would conflict with the proposed Crossing site. The Chairman reported on the meeting with Mr. Appleton of the County Surveyor's Department and Mr. Woods, Divisional Surveyor N.Y.C.C. It had been agreed to resite the Crossing halfway between the present site and Piper Lane. The lighting and paintwork of the Crossing will be enhanced and the footpath will be defined with white lines. The Headmaster of Thirsk Clunty Primary School, who had complained about the present Crossing, had attended the meeting and had been satisfied with the outcome. It was agreed to request the erection of 'School' signs on the approaches to the Zebra Crossing. A letter to be sent to the County Surveyor accepting the recommendations made at the site meeting.

Revenue Estimates - 1988/89 The Clerk presented a breakdown of Estimated Expenditure and Income for the present financial year together with the Sub Committee's recommendations for the year 1988/89. Recommendations for the current financial year included an additional £500.00 for Christmas Lights, a donation of £100.00 towards the Community Minibus Fund and the implementation of a Clerk's Gratuity Fund as recommended by the Auditor. Recommendations for 1988/89 included an allocation of £2,500.00 for replacement windows at Cemetery Lodge, an increase in the Clerk's salary, an increase in the Cemetery Superintendent's remuneration and extra funds for grass cutting. Prop. Coun. Bentley, sec. Coun. Loveden 'to accept the Recommendations of the Sub Committee and request £15,000.00 for revenue expenditure in 1988/89. Agreed.

#### Correspondence

Thirsk Swimming Baths Notice received from the Charity Commissioners regarding the transfer of the Trusteeship of the Swimming Baths from the Flatts Preservation Trust to the Hambleton District Council. This is being carried out in order that the car park can be designated for off street parking and subject to the same restrictions as those in operation in the Market Place. Coun. Davison was named as the Town Council's representative on the Trustees.

Black Swan - Norby Notices received of the intention of Alan Field to apply for the Temporary and Permanent Licences of the Black Swan, Norby and for a Permit for an Amusement Machine.

Pets Cemetery Letter presented from Mr. W. A. Greaves requesting the Council to give consideration to allowing a piece of land on The Holmes, opposite to the play area and on the other side of the river, to be used as a Pets Cemetery. The letter stated that Thirsk Hall Estate, from whom The Holmes is leased, have no objection to the land being used for this purpose. Members referred to a previous decision that the Council should not consider the provision of a Pets Cemetery. Coun. Davison offered to discuss the matter with Mr. Greaves and to enquire about facilities for the burial of pets in the area. It was suggested that the Gerry Green Foundation at Catton may be able to assist.

Boundary Reviews Letter presented from Sowerby Parish Council requesting support to their request to the Hambleton District Council for a review of the boundaries of Sowerby, Thirsk and Bagby and with the suggestion that an area of land between York Road and the Cod Beck should be transferred from Bagby to Sowerby and that Thircon and Thirsk Industrial Park should be transferred to Thirsk Parish, also from Bagby. It was agreed to send a letter to Hambleton District Council supporting the suggestions of Sowerby Parish Council.

#### Matters Arising from the Minutes

Hambleton Leisure Pool

A letter from the Chief Executive H.D.C. confirmed that the

Council has decided to go ahead with the project and the

Consultants are presently preparing plans which will be presented to the appropriate

Committee in due course. The facility is intended to serve the whole of the Hambleton

District and beyond and steps will be taken at the appropriate time to maximise patronage. Thought has not yet been given to requesting extra transport but the situation will be considered nearer the time.

Home Defence Nothing reported.

Mill Gardens Coun. Murkett stated that he has not received a report on the gardens.

White Mare Roundabout It is hoped to receive professional advice on this.

Christmas Lights

The Chairman told the meeting that minor problems had been experienced but the decorations were now in place and Mr. Johnston had done an excellent job. Hambleton District Council had received estimates for making sockets in the Market Place for a Christmas Tree and supports which were considered to be too expensive and it had been decided not to proceed with them. Coun. Roberts had contacted Mr. Harry Woodhead who had offered a tree, container and support ropes. H.D.C. had given permission for holes to be made for spikes to which to attach the ropes. The tree is now illuminated and many complimentary comments have been received. The Chairman thanked Coun. Roberts and all concerned with the tree. It was agreed to await public reaction before seeking an alternative permanent site for future Christmas trees.

Extended Speed Limit - Newsham Road

A letter from the County Surveyor stated that the length of road referred to does not satisfy the speed limit criteria set by the Department of Transport and it is therefore not possible to recommend that such a speed limit is introduced. It is considered that it would now be appropriate to extend the speed limit on Newsham Road to a point immediately to the morth of its junction with Masonic Lane/Picks Lane thereby covering the fire station and the remainder of Picks Lane itself. It is intended to report this proposal to the mext meeting of the No. 1 Area Highway Sub-Committee in February 1988 and the Town Council's comments would be appreciated before the matter is considered by Members of that Committee. It was agreed to seek the support of the Police regarding Newsham Road and await their comments before repl ying to the County Surveyor.

Coach Parking
The Clerk reported on a telephone call from Coun. Hall in which he stated
that the Chamber of Trade's plans for the Coach Park, with spaces for
6 coaches and 4 additional car spaces, are being submitted for the January 1988 planning
meeting, together with costings of £15,000 + V.A.T. Members expressed the hope that
this will be accepted by the District Council.

Conservation Area Enhancement Scheme
Coun. Murkett has yet to contact Mr. Calvert regarding the erection of stiles but does not anticipate any problems.

The Green Coun. Tate reported that the trailer which had previously been parked on the grass at 88, The Green and then removed, is back on the grass again. After discussion it was decided that action should be taken against the trailer's owner who has ignored requests by Coun. Tate and a letter from the Council requesting its removal. Prop. Coun. Tate, sec. Coun. Murkett 'that the Council's solicitor be instructed to prosecute if the owner fails to remove the trailer within 24 hours.' Voting - 3 in Favour - 2 Abstentions. The Clerk to consult Mr. Peter Hatch.

Seats At the request of the Chairman this was deferred until the next meeting.

Cemetery Lodge & Burial Board Office No further quotations for replacement windows at Cemetery Lodge have yet been received. The Clerk

Boundary Reviews Coun. Murkett stated that Bagby Parish should be compensated if it is agreed that Thircon and Thirsk Industrial Park are transferred to Thirsk Parish.

Town Clock Keeper

A letter from Mr. Raymond Stott stated that he is no longer able to
attend to the Town Clock as 'first man' and has handed over those
duties to Coun. Loveden but is willing to be 'second man' and take over for holidays etc.
It was agreed to write to Mr. Stott thanking him for his attention to the clock.

No. 1 Area Highways Sub-Committee have resolved to approve the cantilever widening of Skipton Bridge after considering the proposal against other alternatives including the implementation of a weight restriction. A weight restriction is not justifiable on a bridge which is structurally capable of taking all traffic and it is unlikely that such a restriction would receive the support of the Police. A further letter from the County Surveyor noted this Council's opposition to the propesed bridge widening on the grounds of a feared increase in heavy traffic and stated that the Highways and Transportation Committee will, on 18th December, decide whether or not to accept the recommendation to widen the bridge and such an acceptance would then be followed by an application for Listed Building Consent. In a report to the Committee all the various points raised by several objectors will be included.

Recreation Land - Hambleton Estate

A letter from the Chief Executive H.D.C. suggested that when the centents of the letter are discussed, the press and public should be excluded. Prop. Coun. Roberts, sec. Coun. Murkett 'to accept the suggestion.' Voting - 4 in Favour - 1 Against. It was agreed to defer discussion until the other business of the meeting had been concluded.

Market Place A letter from the Chief Planner & Technical Officer stated that the Leisure & Amenities Committee considered a report on the condition of the cobbles and the problem of insurance claims made against the Council because of accidents caused by loose cobbles. The report identified three alternatives which were: 1. Form additional access across the cobbles (similar to that which is made up of red setts near the clock). 2. Replace all the cobbles with other materials which would be less vulnerable to damage by vehicles. 3. Prepare a programme of refixing the cobbles over the whole of the Market Place. The Committee has recommended to the full Council that Item 1 be pursued after further consultation with the former landowner and that Item 3 be looked into further by H.D.C. staff. The report will be considered on 15th December. Coun. Murkett to ask, at the meeting on 15th December, for the recommendations to be implemented.

Byelaws - St. James' Green
The Clerk had been sent, by a member of the public, an extract of the Law of Property Act 1925 regarding Common Land and the Prohibition of driving motor vehicles elsewhere than on roads. It was agreed not to take any further action with regard to the byelaws until guidance is recieved from the Local Councils Association.

Local Plan

The following observations were made on the Thirsk Local Plan Written

Statement. There is a need for more housing for the elderly and sites
should be allocated for this purpose near the town centre i.e. Waterside. The Plan
should be changed in order to designate the Golden Lion Yard for Residential as well as
Commercial use, which would enable that site to be allocated for elderly persons
dwellings. The widening of the road on the Hambleton Estate from Hambleton Place to
Dowber Way is considered necessary to allow the free flow of traffic which is impeded

Objectives Coun. Tate questioned whether the Council's objectives regarding Litter and Promoting the Town Council were being pursued. As the subject of Litter was Coun. Loveden's objective it was agreed to leave this until the next meeting. The Chairman stated that the Council is being promoted through the involvement with the Christmas Tree and Decorations and attending various functions. Coun. Roberts stated that the Council is being promoted through representation on Committees and members carrying out duties to which they have committed themselves.

Closure of Local Hospitals The Chairman told the meeting that she had been approached by a member of the public regarding the concern expressed by local doctors that the Lambert Memorial Hospital may be on the list of local hospital closures following the closure of the Rutson Hospital at Northallerton and other proposed cutbacks in hospital services. It was agreed to write to the Area Health Authority stressing the benefits derived from the Lambert Hospital to residents of Thirsk and the surrounding villages and stating that any proposed closure would be strongly opposed. Coun. Murkett proposed that the Council liase with the League of Friends and suggested the setting up of a 'fighting fund' in the event of proposed closure, with a donation of £1.(0) from every household in Thirsk and surrounding villages. The Chairman to contact the League of Friends.

Council's Tourist Promotion Officer had told her that the decision of the Policy and Resources Committee regarding finance for the signs, had been awaited before submitting, the centent of the signs to the Department of Transport for approval. Coun. Murkett told the meeting that the finance had been approved.

Financing of the Thirsk and Sowerby Tourist Guide A letter from the Secretary of the Museum and Tourist Information Centre stated that Thirsk Museum Society, Tourist Information Centre, Civic Society, Chamber of Trade, together with representatives of Thirsk Town Council, Sowerby Parish Council and Hambleton District Council have formed a Joint Committee to promote Thirsk and Sowerby and District for Tourism and intends to produce Tourist Information publicity for distribution to encourage visitors to the area. The Committee wish to produce a modest brochure in the form of a single folded sheet in two colours containing a map, street plane and local information. The cost of printing 15,000 copies will be in the order of £400) which the Committee wishes to finance by obtaining sponsors from within the local are.t. The Town Council is asked to consider contributing towards the cost of the project which will bring considerable benefit to the Town and area. A letter from the Secretary of the Chamber of Trade stated that at a meeting of the Steering Committee, he had said that he believed £200 would be available for a one page advert, listing in alphabetical order the names of the members of the Chamber of Trade, but the offer had been withdrawn when Jouncillor Bentley had stated that some councillors had expressed the view that money from the Council was contingent upon the leaflet being non-commercial. Coun. Murgett stated that Coun. Bentley could not speak for the Council as the Town Council had not appointed a representative to the Committee. Nominations were invited -Council entley was nominated and agreed to represent the Town Council on the Committee. Cous. Murkett reminded members that the Council's policy is to support commercial venture as it had done when the previous town map and punlicity guide was published. It was agreed to reply to the request for assistance by stating that the cost of printing should be raised by advertising but that the Town Council will underwrite any loss up to 250.00.

Correspondence

Reply received from the Chief Planner & Technical Officer to this Council's complaint that a tree in the hedge at 2, Shire Park has been cut down.

The latter stated that the site has been visited by the Enforcement Officer when it was seen that the tree had been cut down to hedge height. Condition No. 3 of the planning comment referred to the retention of boundary hedges on the site and in view of the fact that the hedge has not been removed, it is the opinion that there has been no breach of the conditions of planning consent. Members were of the opinion that this is an unsatisfactory situation and the matter will be taken up by Coun. Murkett with the Chief Planning Officer.



#### Matters Arising from the Minutes

A letter from the District General Manager of the Northallerton Health Authority stated that he can confirm that the Authority has no plans to close the Lambert Memorial Hospital. It was reported that there are plans to extend the hospital.

Parish Government Course Couns. Roberts, Murkett and Davison expressed the wish to attend the course. Coun. Loveden stated his intention to attend the course but may go as a delegate from Carlton Miniott Parish Council.

The fees were quoted as £66.00 for a Resident (£10.00 single room supplement) and £40.00 for a Non-Resident. Prop. Coun. Murkett, sec. Coun. Foxton 'that the Council pay the fees of Members as Non-Residents with Members paying the balance if attending as Residents'. Agreed. The delegates stated their intention to attend as Residents.

The Chairman and Vice Chairman had visited Mrs. Fernandes on the occasion of her 100th birthday and presented her with a card and plant. A letter of thanks had been received by the Chairman.

The Greens Inspection not yet carried out by the Sub Committee. It was pointed out that a scheme of edging The Greens such as that being carried out in Sowerby would not be practicable as Sowerby Greens are owned by the Parish Council whereas Thirsk's Greens are only held on lease.

<u>Magistrates</u> Letter of thanks received from the Chairman of the Magistrates for the Council's congratulations on their stand against disorderly conduct.

Abandoned Cars/Chapel Street Garage

Health Officer stating that the abandoned vehicles

will be investigated and that the Chapel Street Garage site has been inspected where
there were nine different types of vehicles awaiting repair outside the garage. A copy
of this Council's letter has been sent to the Planning Officer for any action that he may
wish to take.

Recreation Lane - Hambleton Estate Nothing reported.

Parking - The Greens The Clerk reported that Mr. Hatch had sent a letter to the occupant of No. 88, The Green and the trailer had been removed from the grass and is now parked on the road in front of the house. A letter from the occupant of No. 89, The Green asked the Council to take action over the parking of a large van, the property of the occupant of No. 88, in front of her house. A letter from the Assistant Secretary L.C.A., in reply to the enquiry re possible amendment of the byelaws, stated 'if the area known as St. James' Green is registered as Village Green within the Commons Registration Act 1965, then the byelaw merely confirms existing legislation as it is already an offence to drive a car over a village green. The Town Council cannot permit a a criminal act and cannot therefore give permission for cars to be driven onto a registered area, even if that area has always been used as a highway. If it is not registered, then the general principle involved would be that a law must be applied to all equally and that to enforce the byelaw the Council must apply it to all the people The Clerk had taken advice and been toldthat when the Greens were registered as Common Land, the residents should have been advised to register their Rights of Way. The fact that they had not done so does not preclude them from having

the right to drive to and park in front of their own property as this right of way would have been establised over the years by vehicles servicing the properties around The Green. Two members of the public, Mr. Palliser and Mr. Ogleby requested the right to speak. Prop. Coun. Hall, sec. Coun. Tate 'to allow a limted time for them to speak.' Agreed. Mr. Palliser stated that the Council could not permit an illegal act by allowing vehicles to park on a registered area and that no one had rights of way over The Green unless they had applied for them at the time when the land was registered. Mr. Ogleby stated that the residents of The Green had not been made aware of the fact that the land was being registered and pointed out that Mr. Palliser had been a member of the Council at that time. Prop. Coun. Hall, sec. Coun. Roberts 'that a meeting be called with the residents whose properties front onto The Green to try to resolve the problems of park-ing and to ask Mr. Hatch to be present to explain the legal situation.' Agreed.

Objective - Litter Coun. Loveden stated that he considered the situation regarding litter in the town has improved. It was reported that the Street Sweeper is ill and that the Sowerby Street Sweeper is deputising. It was agreed to request a copy of the street sweeping schedule which was to have been revised. Coun. Craig agreed to request extra litter bins for Ingramgate and Stockton Road.

Provision of Room at the Town Hall for Council Use

Of the C.C.A. and the Ghairman of

Hambleton C.A.B. regarding the use of the C.A.B. office at the Town Hall. Coun. Bentley

stated that the use of the C.A.B. office had only been a suggestion. Prop. Coun. Murkett,

sec. Goun. Tate 'that this Council does not consider the use of rooms at the Town Hall'.

Agreed.

Minutes of a Meeting of Thirsk Town Council, held in the Court House on Monday, 15th February 1988 at 7.00 p.m.

Apologies for Absence received from Couns. D. E. Loveden & D. S. Murkett

Minutes The Minutes of the previous meeting, having been circulated and approved, were signed by the Chairman. Prop. Coun. Roberts, sec. Coun. Davison.

#### Matters Arising from the Minutes

Mill Gardens & White Mare Roundabout Due to the absence of Coun. Murkett, no report was available. The Chairman to contact Coun. Murkett. Coun. Roberts stated that more low growing conifers are needed for the roundabout and these should be planted in the near future.

Christmas Lights & Decorations The Clerk reported that all but one of the sponsors have paid for the decorations and one promised donation has not been received. Reminders have been sent. The Chairman told the meeting that the decorations have been put into store. Mr. Johnston's account presented for payment.

Newsham Road A letter from Chief Inspector Turnbull, Police Traffic Management, stated that the Police have given their support to the proposal to extend the speed limit on Pick's Lane/Masonic Lane from its junction with Newsham Road and on Newsham Road from its junction with Station Road to a point just north of Pick's Lane as this will give more uniformity to the length of roads in question. The length of Newsham Road from Pick's Lane to Cemetery Road does not meet the Department of Transport criteria and the Police cannot give support, at this time, to the Council's request for the speed limit to be extended on this stretch of road. Any road safety benefit is more likely to be achieved by the provision of street lighting and the Police cannot help the Council to achieve this facility any quicker than through its own approaches. Certain highway lighting automatically imposes a 30 m.p.h. restriction on any road. Upon the installation of lighting on Newsham Road, the proper action in support of speed limit criteria may well be to apply for that length of road to be derestricted.

Coach Parking The District Council's planning application for a coach parking layby submitted to this meeting.

Conservation Area Enhancement Scheme Nothing reported.

Seats Survey of seats not yet completed. The Clerk told the meeting that the claim to Municipal Mutual Insurance for repairs to the R.A.O.B. seat has been withdrawn. The seat had been damaged accidently and the person who had been responsible for the damage is meeting the cost of repairs.

Zebra Crossing - Long Street

The crossing has been re-sited. Reply from the County
Surveyor regarding signs, awaited. Coun. Craig requested
that Mr. Woods be reminded of the agreement to denote the footpath with white lines.

Boundary Reviews Reply awaited from Sowerby Parish Council.

Recreation Land - Hambleton Estate

Coun. Tate stated that he had been told by Mr. Johnson of the District Council's legal department that it is not certain that the Kettlewell Trust land will be available for purchase as recreation land. It appeared that Barkers Ryebeck Farms may apply again for a Certificate of Alternative Development in respect of their land, which is designated as public open space, and if they are successful, the Kettlewell may take the same action. It was stated that if the land was designated for building, the price would be £70,000.00 per acre as opposed to £17,000.00 as agricultural land. It was agreed to enquire from the District Council, the current situation with regard to this matter.

Grass Cutting It was agreed to use the District Council's form of tendering for grass cutting, with minor amendments.

Street Sweeping A copy of the street sweeping rota received.

Dogs Fouling Footways

Reply awaited from the Chief Environmental Health Officer H.D.C.
Coun. Craig stated that the matter is being discussed by the
District Council. At the suggestion of Coun. Tate, it was agreed to write to the
C.E.H.O. again requesting consideration of the employment of a Dog Warden.

Lights - Steads Yard & Roses Yard Nothing reported.

Post Office A letter from the District Manager, Post Office Counters Ltd, Leeds stated that the Post Office Counters Business pays a considerable amount of attention to the Quality of Service, and performance is constantly monitored by means of regular samples taken at times generated randomly by computer. As a result, it is confidently suggested that the speed of service given at Thirsk is good overall and this has a bearing on the all-round standard of service offered, including the criterion of accommodation. This means that if customers are served quickly and efficiently, there is much less likelihood of them being inconvenienced by having to queue outside the office. The deficiencies in the accommodation at Thirsk Post Office are acknowledged and these represent part of an Estate inherited from the past. There are another number of offices which are deficient and although money is being spent on renovations, it is limited. The situation is that currently there is no money to spend on Thirsk Post Office and it would be wrong to suggest that funds will be available in the near future. Efforts have been directed at the counter service which has been reviewed and augmented by additional resource at known busy periods such as Monday mornings, Market Day. The Thirsk Branch Manager has stated that the occasions when customers have to queue outside are very rare and relate to exceptional periods like Christmas. It is accepted that disabled people may have difficulty with access and this is due to a legacy from the past when buildings were built differently to the present time. It is, however, often possible to make special arrangements for disabled people who are unable to negotiate a difficult access. If such people would be so good as to telephone the Branch Manager, he will be pleased to help if at all possible. It has been found from experience that the problem can often be solved in this way.

Letters from Councillor Watts stated that he has taken up the matter through the District Manager at Leeds and that as he has now been appointed as the representative of the Yorkshire L.C.A. on the York Post Office Advisory Committee, he will be able to take up the case of Thirsk Post Office, through that Committee. It was agreed to send a copy of the District Manager's letter to Councillor Watts and ask him to pursue the matter and to write to the District Council, enquiring if the Post Office has a statutory obligation to provide facilites for the disabled.

Footpaths - Market Place Reply awaited from the County Surveyor.

Chapel Street A letter from Mr. Woods stated that repairs will be carried out to the area within the highway in the near future. Coun. Hall reported that the repairs have now been carried out.

Townscape Scheme Details of the scheme received from the Chief Planner & Technical Officer.

Home Defence A letter from the Chief Executive H.D.C. stated that the matter has been raised with the County Emergency Section and this Council's letter forwarded to the County Emergency Officer. The Clerk reported on a telephone call from Mr. Jones of the County Emergency Section who stated that the Three Tuns Hotel is Thirsk's Control & Information Post. The suitability of the Community Centre at Norby will be investigated but is necessary to have a building which is constantly manned and has a telephone. It was noted that a course of training as Community Advisors is to be held at Richmond in April and May.

Objectives The Chairman stated that she did not think that the Council is being success ful in achieving the 'objectives' set in August 1987, referring to 'Promoting the Town Council' and tackling the 'Litter' problem. Coun. Roberts stated that members were promoting the Council by working on Committees and taking part in activities in the community. Coun. Roberts also considered that the litter situation has improved, there being a street sweeping plan, private yards and alleyways now being swept by the street sweeper and the increased number of litter bins in and around the town. Coun. Davison was of the opinion that 'objectives' are counter productive. Coun. Bentley stated that he had pursued, and been successful, in his objective which was to liase

Meeting with Residents of St. James' Green The Chairman reported on the meeting with 40 residents of St. James' Green, held on

5th February. The meeting had been informed by Mr. Hatch, Solicitor, that no one has the right to park on the Green, which is registered Common Land, although if residents park in front of their own property, the matter would only become a cause for complaint if they act unreasonably by parking in front of or obstructing their beighbours property. The sensible means of controlling erosion and parking would seem to be by co-operation between the residents and their 'policing' of the area. A Residents Association had been formed with a Steering Committee of seven residents plus Couns. Foxton, Craig and Davison. A letter to the Council from the Chairman of the Committee stated that the residents wish to secure the right to legally park on the access roads outside their premises and for the access roads to be maintained to a reasonable standard. They also wish to restore and maintain in godd condition and appearance, the Green known as St. James' Green as quoted in the Byelaws. Attention was also drawn to the numerous potholes on the access roads which are tending to accelerate the erosion of the Green. Coun. Hall suggested that the access roads should be de-registered and residents given permits to park outside their own properties. The Clerk pointed out that Common Land cannot be de-registered unless alternative land is provided to compensate. The Chairman stated that she is looking into the question of de-registering part of the land. It was agreed that action should be taken regarding the potholes. Prop. Coun. Tate, sec. Coun. Bentley 'that the Council allocate £50.00 for the cost of filling in the potholes.' It was agreed to enquire of Mr. Woods if any road planings are available for this purpose.

Cametery Sub Committee Meeting The Chairman reported on the meeting where the size of memorial stones for the Garden of Rest had been discussed.

It had been suggested and was being recommended by the Committee that the size should be limited to small tablets of approximately 10" x 10", to be erected along the border of the Garden of Rest. Coun. Loveden had agreed to produce a drawing. The matter of a charge being made at the 'Exclusive Right of Burial' rate for the erection of a memorial wase on the Garden of Rest had been discussed and it had been considered that no charge should have been made. Prop. Coun. Foxton, sec. 'that the £50.00 received for the erection of a vase on the Garden of Rest should be refunded.' Agreed. The Chairman also reported that the Burial Board Office now has a desk and one chair, more chairs being required. The Clerk stated that it had not been possible to purchase chairs from the District Council.

Replacement Windows for Cemetery Lodge Quotations had been received from two sources, one submitting two prices but insufficient details.

It was agreed to seek further details and consider the quotations and window styles at a meeting on 26th February. Recommendations to be put to the next Council meeting.

Proposed Car Parking Charges

Members commented on Press reports that the District

Council is proposing to implement car parking charges in
the Millgate Car Park. Coun. Craig stated that he is of the opinion that the proposal
will not be accepted by the full Council. It was agreed to write to the District
Council registering objections on the grounds that it would be unfair on people who
work in the town and have to park on the Car Park because of the Disc Parking Scheme
in the Market Place, it would discourage tourists and people from the surrounding villages will travel to shopping centres which provide free parking, adversely affecting
the prosperity of the town.



#### Reports

The Chairman told the meeting that, due to other commitments, she will be 'standing down' from the Office of 'Mayor' at the end of one year in office in May.

Coun. Roberts reported that the re-wiring of the Town Hall Annexe will be commencing in the near future.

Coun. Davison reported that the roof of the Swimming Baths had been damaged by high winds. He referred to the need for a 'Learner Pool' at the Baths where there is a waiting list of people wishing to learn to swim. Coun. Craig stated that £90,000 had been allocated by the District Council in 1983 for a Learner Pool at Thirsk. The District Council to be asked why the matter was not progressed.

Swimming Baths Manager Coun. Hall stated that Mr. Currie, Manager of Thirsk Swimming Baths, is retiring at the end of March and suggested that a letter be sent expressing appreciation of his work. It was agreed to send a letter from the next meeting.

Nursery Site Decision Coun. Davison commented on the derelict state of the Nursery site, Salem Chapel and Golen Lion and was told that nothing will be done to improve them until the decision of the Inspector is known regarding the Public Enquiry into the application to demolish Woollybacks, 22, Finkle Street, to allow access to The Nurseries. It was agreed to write enquiring when the decision will be made known.

The meeting ended at 9.25 p.m.

Minutes The Minutes of the 1987 Annual Assembly were read to the meeting.

Chairman's Report The Chairman referred to the Council's four new members, the supermarket sage, and the public enquiry into the application to demolish 22, Finkle Street. There has been an improvement in the parking situation in the town with Disc Parking regulations being enforced. The Town Clock has been refurbished, a new Cemetery Superintendent appointed, Cemetery Lodge upgraded and the Burial Fees reviewed and revised. The Christmas Lights scheme was a success for the Council. It is hoped that the parking problem on St. James' Green can be resolved. Much has been achieved in the past year and many matters are on a more businesslike footing.

#### Reports from School Governors

Thirsk County Primary School
The written report submitted by Coun. Craig stated that
numbers in the school have fallen but numbers in the
Nursery class are healthy. There has been a change in staffing and class sizes and the
new system appears to be working well. The report also referred to the Education Act 1986,
the Annual Parents Evening, educational visits and school trips.

All Saints' R. C. School Mrs. Greensit's written report referred to school visits and trips and a Parents/Governors Meeting. In a letter, Mrs. Greensit stated that everything in the school is running smoothly and there are no problems.

Sowerby County Primary School Coun. Roberts' report included references to school numbers, staffing and the emphasis on science which now has to be taught to all pupils and which has meant a lot of extra training for teachers.

Reorganisation of Governors takes place in September 1988 and it may mean that Thirsk Town Council will no longer have a representative on the governing body of the school.

#### Reports from Members who represent the Council on Outside Bodies

Coun. Loveden reported that there has been reorganisation of the C.A.B. at Northallerton where there is a staff of 16, including one trainee. The number of enquiries at Thirsk have greatly increased during the past year. It is anticipated that there will be an increased workload with the proposed changes to the Social Fund. Coun. Loveden stated that the C.A.B. is funded by the County and District Councils and it is no longer true that if donations are received from other sources, the funding is decreased accordingly.

Civic Society Coun. Tate referred to the Civic Society's achievement in its role at the Public Enquiry into the application to demolish 22, Finkle Street, the Townscape Scheme, Parish Map and Survey of Local Footpaths.

Town Hall Coun. Roberts reported that the Town Hall is going from strength to strength. The floor is in good condition, the interior has been redecorated and the re-wiring of the annexe almost complete. New lighting has been installed for the stage area. The replacement of the noisy heaters is the next priority. Coun. Murkett suggested that the Town Hall Committee obtain estimates for replacement heaters and that Sowerby Parish Council be asked if they are agreeable for the cost to be met from the funds set aside by the two Councils for the Town Hall. It was agreed to write to Sowerby P.C. regarding this matter.

Thirsk Swimming Baths & Ings Water Project Coun. Davison reported that Mr. Currie has pursued the project and is awaiting the Yorkshire Rural Community Council Architect. Coun. Murkett to take up the matter with the Y.R.C.C.

Parochial Charities Coun. Craig reported that £48.00 had been distributed from the wrightson Charity at Christmas 1987.

Pavements around the Market Place

Coun. Turton stated that he had raised this matter

Tate stated that he had attended the course before he became a Councillor.



Footpaths Coun. Turton had told the Annual Assembly that the County Surveyor would support a phased scheme of new pavements around the Market Place when the cobbles are relaid.

Home Defence Coun. Bentley stated that he is in discussion with Mr. Jones of the County Emergency Department regarding a new C.I.P. for Thirsk.

The Greens A letter from the Chairman of the Residents Association thanked the Council for the prompt action regarding road planings which had been used by volunteers to fill some of the potholes as a temporary measure. The letter requested that the Council approach the Police regarding the parking of cars on the grassed areas of the Greens to prevent further erosion and suggested the immediate erection of signs stating 'no parking on the grassed areas.' A further letter gave the results of a survey carried out with the residents of The Green. The Clerk told the meeting that enquiries have been made to the Yorkshire L.C.A. regarding having The Green 'deregistered' as Common Land. It is not possible for this to be done but there is a scheme of Exchange of Land whereby if an alternative tract of land, of the same area as the Common Land, can be identified and registered, the original land can be freed from the restrictions. It is apparently a complicated process but it can be done if alternative land can be found and details are being obtained from the L.C.A. It was agreed to reply to the Residents Association stating that at the present time it is not possible for their requests and suggestions to be carried out.

Car Parking Charges

A letter from the Chief Executive H.D.C. stated that the Leisure & Amenities Committee, in considering its revenue estimates for the coming financial year, has asked for reports to be submitted to a future meeting on certain charging policies, including the question of whether charges should be introduced for the use of Council car parks. In the event of the Council deciding to pursue this matter further, the Town Council's views will be taken into account.

Learner Pool - Thirsk Swimming Baths

A letter from the Chief Executive H.D.C. stated that the sum of £90,000 for a learner pool was not included within the 1983 capital estimates or subsequently. Technical Officer stating that the developer is suggesting that two new town houses on Long Street are numbered 123 & 125 Long Street respectively and the tree bungalows at the rear be known as numbers 1, 2 & 3, Bradbury Close. This had been a matter requiring an early reply and the members consulted had considered the suggestions suitable.

Abbeyfield Letter presented from the Chairman of the Abbeyfield Thirsk & Sowerby Society pointing out the problems being encountered with the old Abbeyfield House in Sowerby. The Society is faced with three possible alternatives 1. To renovate and refurbish the Old House - which is not financially possible without very large donations to take the place of grant-aid which is not available. 2. To demolish the House and to erect on the site a new building, designed similarly to the present 'Mitchell House' but incorporating a front elevation similar to the existing Old House, to blend in with the village, but this might be difficult, in view of the fact that it is a listed building.

3. To put it up for sale on the open market and to use the proceeds to buy a new site in the village but such sites are not easily available. The Society invites the opinions and advice of local people. It was agreed to suggest that alternative No. 3 would be the most suitable.

Application for Justices' Licence Notice received of the intention of David Ross Christy to apply for a Justices Licence authorising him to sell by retail any intoxicating liquors for consumption on or off the premises known as Stoneybrough. Coun. Roberts stated that there is a need for 'Public House' facilities for the many residents of that area of Thirsk. Coun. Murkett stated that nearby residents were opposed to the application. By a vote of 5 in favour of the application - 2 against and 2 abstentions, it was agreed not to oppose the application.

Transfer of Licence Notice received of the intention of Stuart Price Lowe to apply for the transfer of the 'Off Licence' in respect of 9, Market Place which was previously held by Harry Woodhead.

Skip Letter received from F. D. Todd & Sons stating that due to increased costs, mainly in the fee charged for the use of the tip, it will be necessary to increase the cost of emptying the skip to £26.00 per time. The weekly rental would remain the same. Coun. Hall pointed out that when the Estimates were considered, it had been agreed to purchase a skip for use at the Cemetery, the cost of which would be approximately the same as two year's rental. The Clerk had made enquiries and been told that the cost of a new skip would be in the region of £350.00. Prop. Coun. Hall, sec. Coun. Roberts 'that the Council purchase a skip for use at the Cemetery.' Agreed.

Street Naming Letter received from the Chief Planner & Technical Officer stating that the developer has suggested that the cul-de-sac to the rear of Stoneybrough Restaurant be known as Stoneybrough Close and invited the Council's comments. It was agreed that the name is suitable.

The property manager of the Company has again been contacted and has stated that a new application is to bd submitted seeking approval for the sign to be displayed at fascia level. The sign currently on display is to be removed.

Granada, 48 Market Place

The sign was given approval to be displayed at fascia level and the owners have intimated that the sign currently being displayed is to be lowered to fascia level.

Letter received from the Chief Executive H.D.C. stating that the owner of land, between Millgate Car Park and the Beck, has requested the District Council to grant him a vehicular right of way from the Car fark to facilitate the movement of his horses on and off the land. In exchange he is prepared to convey to the District Council a twelve foot strip of land which could then form part of the footpath along the Beck from Blakey Lane to Norby. If the land were to be acquired, it is anticipated that the Leisure & Amenities Committee may consider that its acquisition would fall within the Council's normal policity for recreational provision, whereby it acquires land and then leases it to the relevant Parish Council for management. The Town Council's views are requested and in particular, confirmation that the Council could undertake the relevant works to remove the existing hedge, fance the land and provide an appropriate footpath. No firm decision has, as yet, been taken and the views of the Town Council are being sought in order to give the Members of the Committee as full a picture of the options available as possible. It was decided that a reply be sent, agreeing in principle and requesting a site meeting in order to discuss the matter more fully.

Recreation Land - Hambleton Estate - discussed 'in camera' - as requested by the District

Council and resolved earlier in the meeting.

Letter received from the Chief Executive's Dept. H.D.C., regarding a statement made by Coun. Tate in 'open Council' at the February meeting, and reported in the local press, on a matter previously discussed without the presence of the public and press, the outcome of which was stated to be that the ability to acquire the land would appear to have been lost. a) County & Controlled Schools' Admissions Arrangements

The Governors discussed and noted the arrangements.

b) Financial Responsibilities

The Governors are to have more say in the spending of the annual capitation.

Mr. Paxton outlined the present system of control over the spending of the capitation.

The Governors received the memorandum and resolved to delegate to the Head Teacher their powers relating to the capitation allowance.

Mr. Paxton to prepare a financial report for the capitation allowance and present it to the Governors each year.

c) Education Regulations 1987.

3. Letter from N.Y.C.C. regarding insurance of pupils whilst at school.

N.Y.C.C. are responsible for the pupils whilst in their care, but no compensation will be paid for injury unless negligence can be proved against the teacher who was in charge of the pupil at the time of the accident.

Mr. Paxton outlined the proposals put forward by the N.Y.C.C.

After a discussion it was agreed to include details of the County Insurance Scheme in the next newsletter.

4. Mr. Paxton had received a telephone call from N.Y.C.C. asking if the school wished to have an access gate into the adjoining field to the north. It was agreed that an access gate would be useful, provided that it was positioned at the western end of the field.
